

NOTICE OF OPPORTUNITY FOR PUBLIC HEARING

Notice is hereby given that upon request by any interested person(s) a public hearing will be held by the Tri-County Metropolitan Transportation District of Oregon (Tri-Met) at 3:30 P.M., Wednesday, February 25, 1987, at the Fortland Building, 1120 SW 5th Avenue, Second Floor, Meeting Room C, for the purpose of considering a project for which federal assistance under Section 6 of the Urban Mass Transportation Act of 1964, as amended, is being sought.

The proposed application requests \$139,200 (100% Federal funding) for two projects. The first project would examine cost efficiencies of providing late night (owl runs) service for one year by a private provider under contract with Tri-Met (Budget: \$87,600). The second project would examine cost efficiencies of provision of service for one year to the Westover area by a private provider under contract with Tri-Met (Budget: \$51,600).

The project is in conformance with comprehensive land use and transportation planning in the area and will be programmed in the Transportation Improvement Program. A statement of Tri-Met's charter bus service is available for inspection at the Tri-Met Administrative Offices. Tri-Met will not be engaging in school bus operations. Private transportation providers will be given the opportunity to submit proposals for both projects.

The projects are currently under review by the state and district clearing houses.

At the hearing, Tri-Met will afford an opportunity for interested persons or agencies to be heard with respect to the social, economic and environmental aspects of the projects.

A copy of the draft grant application for the proposed projects and a transit development plan for the area are currently available for public inspection at Tri-Met, Public Services Division, 4012 SE 17th Avenue, Portland, Oregon, 97202.

**FOR THE SANITARY SEWER REHABILITATION

Sealed bids will be received at the office of the City Recorder, City Hall, Room 205, Salem, Oregon, until but not after 11:00 a.m., Local Time on March 4, 1987, at which time all bids will be publicly opened and read aloud at the Council Chambers, Civic Center, 555 Liberty Street S.E., Salem, Oregon for the "SANITARY SEWER REHABILITATION IN THE ALLEY WEST OF CHURCH, BELMONT TO GAINES."

The proposed work consists of: Insituforming or replacing 664d lineal feet of eight-inch (8") sewer pipe, rehabilitation of three (3) manholes, and appurtenant work.

Plans, specifications and other bid documents may be inspected and obtained at the office of the City of Salem, Department of Public Works, 555 Liberty Street S.E., Room 325, Salem, Oregon. The bidder shall not file the book of "Standard Construction Specifications" with his bid.

Bids shall be made on the forms furnished by the City, addressed, and mailed or delivered to the City Recorder, City Hall, Room 205, Salem, Oregon 97301, in a sealed envelope plainly marked "FOR THE SANITARY SEWER REHABILITATION IN THE ALLEY WEST OF CHURCH, BELMONT TO GAINES," and the name and address of the bidder.

A surety bond, cashier's check or certified check of the bidder, made payable to the City of Salem, in the amount of ten percent (10%) of the bid must accompany each bid as security. Bid security of all save the three lowest bidders will be returned following the bid opening; all bid security will be refunded upon execution of the contract by the successful bidder.

No bid will be received or considered by the City of Salem unless the bid contains a statement by the bidder that the provisions of ORS 279.350 shall be included in his contract.

The attention of bidders is directed to the provisions of Chapter 97, Salem Revised Code, concerning un-layful employment practices. Violation of such provisions shall be grounds for immediate termination of this contract without recourse by the contractor.
