I'm So Disappointed

I am writing to express my sincere disappointment and my strong anger with the recent issue of the Portland Observer, February 18, 1987.

My sincere disappointment is with the entire tone of two (2) articles: one a front page article using a three (3) week old press statement from James Hall and written by Ray Hanson. The other is a lengthy series of inflammatory quotes by this same apparently remarkable Sabin Community Vice-President, Mr. Hanson. In the Northeast community we have sufficient problems needing a positive response from citizens and other members of the entire community that I am ashamed to think that legislators in Salem and public servants at City hall might think that Mr. Hanson reflects a broad cross section of this community.

Now to my real anger and frustration with the February 18th issue: twenty-four (24) column inches devoted to Mr. Hanson's ill-informed, gossippy and sanctimonious remarks on "Northeast Politics". Hanson, a Northeast Portland resident for little more than two (2) years, elected in a farcical election to serve as first vice-chair of a neighborhood association, does not in my mind deserve the type of press which one might expect if he had recently been elected to the Portland City Council, or as Chair of the Northeast Coalition of Neighborhoods.

His comments are bitter, divisive and among the most self-serving I have read in any local column. While I have had my differences over the years with some of the local leaders Hanson attacks, I believe that the viciousness of the personal attacks against Ron Herndon, Mayor Clark and even fellow church member, Commissioner Bogle, are guttersniping remarks, undeserving of one column inch of a legitimate publication. I abhor those comments and urge your readers to let you know that they don't appreciate wasting their money to read such diatribes.

Further, as President of a neighborhood which shares some of the same community members as Sabin, the Irvington Community Association, I deeply resent and completely reject Mr. Hanson's stupidity regarding "Fifteenth Street". Point one: Fifteenth is a numbered avenue, not a street, Mr. Hanson. Maybe after five (5) more years in Portland you'll learn a little more about the city. Point two: Fifteenth does not serve as a "railroad track separating rich from poor, Black from white." It serves in our community as a uniting avenue (yes with too much traffic), but not as a symbol of division. Point three: Commissioner Koch does live in an HCD neighborhood, Sabin, but alas, Mr. Hanson, he lives, according to you, on the "rich side of Fifteenth" and not in the HCD designated area.

The last paragraph, headed right wing, etc., to me is truly frightening. From a neighborhood perspective, we have people of all faiths, races and ethnic backgrounds. Dragging one church into the middle of local neighborhood politics as Mr. Hanson is attempting to do, will destroy the entire concept of neighborhood associations and coalitions. I am delighted to see some Maranatha Church members involved in neighborhood associations; Irvington's former chair was a member of that congregation, and our Board last year contributed to that church's Social Justice Ministry for it's efforts to provide emergency services. However, the church's influence must not extend to taking over neighborhood associations. Mr. Hanson's self-aggrandizing commentary on the Bible would be best left to the Sunday School: since he has a place for the other three (3) major leaders, Hall, Bogle and Koch, perhaps in his own megalomania he is the martyr bringing them all to-

Healthwatch

Unlike "The Trouble With Harry", the trouble with PPOs is not that they are dead but that they are multilying. Perferred provider organizations (PPOs) are springing up across the country under the promises of better care at lower costs. What many people feel they are bringing is more limited care with less personal choice.

PPOs are still being presented to the consumer as a way to let insurance companies choose the "best" providers, so that consumers can choose within a "cost contained" population for their health care. Like another dinosaur rising from the fossils, this is simply not the solution to our modern crisis in health care.

While an ever-increasing percentage of our gross national product goes to the nation's "health" care (now around 13% of the GNP!), we seem less and less able to provide and guarantee care for our seniors, the indigent, the medically needy, pre-natal care, rural care, as well as general preventative care for the majority of the population. The PPO direction of insurance companies is at best a bandaid on a cancer, and I feel, as do many others, that it is an alarming step backwards in American medicine.

The problems associated with the PPO design have been numerous and have received must publicity including a recent one-hour documentary on PBS. Some of the major problems include:

- 1) With an emphasis of cost per disease condition, we find that PPOs have little incentive not to use the entire reimbursement even when the individual case may warrant less care. The converse is even less attractive: this being the case of holding off needed care because the allotted dollars have already been spent on the individual patient.
- 2) Often PPOs will only cover services rendered at particular hospitals. You may have a condition that is rarely treated in the covered hospitals, yet you cannot go to one with a specialist in your area because his/her hospital is not included.

3) PPOs often exclude entire professions within the healing arts. Many policies offer choice of doctor but define the term "doctor" differently from policy to policy. The charge that PPOs circumvent state non-discrimination laws will probably be decided in the Supreme Court. Currently it is up to the consumer to find out if their policy includes such providers as clinical psychologists, podiatrists, chiropractors, nurse practitioners, naturopathic doctors, optomitrists, etc.

4) Narrowing the selection process and limiting professional participation in PPOs is contrary to all principles of open market competition.

These are some of the major concerns that have been brought against the PPOs. Groups such as Fair Share and others have made the redress of current PPO trends as a major legislative goal of their present agendas. In addition to the numerous consumer groups and individuals challenging the growth of PPOs in this country, there are many professional organizations which see their members as being discriminated against by the PPOs, and who have joined the fight against this narrowing of American health care.

While it is clear that we need some measure ofd

While it is clear that we need some measure of change in our current health care, the problem is not a lack of PPOs. The very basic problems include high risk therapies, liability costs, high levels of side effects in drug therapy, an over-emphasis in high-tech, late-stage and experimental care, unnecessary surgeries, as well as an almost complete ommision of preventative and individualized care directed at improving quality as well as decreasing risks of serious illness.

It is sad that a country that has such advanced knowledge in medicine cannot find a way to provide care to all its citizens. While this is an acknowledged problem, I do not feel that we can depend on profit making institutions such as insurance companies to devise a way to remedy the problems of the poor or the elderly. Certainly the PPO is far from the solution.

True, we have Jessie Jackson and others, but the question comes to mind, "What can they do?" The damage has been done.

Every time a Democratic President leaves office after doing a good job, along comes a Republican President and, not only undoes the good that has been done, but somehow seems to fan the fires of racism with an idealism contrary to human dignity. I hasten to add that no Republican President, past or present, is being labeled a racist.

But when the power of this nation's highest elective office is used to thumb its nose at respected spokes-persons for Blacks and other minorities, when the power of this nation's highest elective office is used to relegate civil rights to a state of regression, when the power of this nation's highest elective office is used to stalemate the Constitutional rights of Blacks, people

take notice. And, as fate would have it, those who do, usually manage to sway public opinion in their favor.

This perhaps explains how a place like Forsyth County, Georgia, can serve as a breeding ground for racists and bigots, or a foreign leader branding Blacks and other minorites as inferior to Whites, or the epidemic resurgance nationwide of anti-semiticism towards Jews.

Races are pitted against each other in violent confrontations in the schools, on the job, and in the streets. It has all the appearances of a well-orchestrated organized conspiracy. And it's gaining momentum.

Simply stated, this nation is on a collision course, and its aftermath promises to be nothing less than tragic. But it's not restricted to America along. It's in England, it's in France, it's in Russia, it's in China, it's everywhere. Racism, which sprung its roots in the "land of the free" and "the home of the brave", has effectively mastered the art of widespread fear. Racism, which many thought was lying dormant, has been injected with new life by a society corrupt with greed and power.

We need new leadership. We need someone who would remind Forsyth County, Georgia, that this nation is still governed by the Constitution of the United States, not by laws adopted by a racist community. We need someone to remind foreign leaders that before they espouse racial superiority, they should inventory grave sites in this country to be reminded that Blacks and other minorities gave their lives and shed blood to preserve peace in their homeland. Most of all, we need someone to bring into focus the dreams, hopes, and aspirations of some of our past and present heroes, lest this country crumbles to its knees in dispair.
