Attention Renters
You may qualify for Housing Assistance under the Section 8 Rental Assistance Program for low-income families, handicapped, disabled and elderly persons. The Housing Authority of Clackamas County will be accepting applications for families who qualify for one, two, three, four and five bedroom units effective April 27, 1987 at 8:30 a.m. Eligibility will be based upon income and family size.

Assistance is in the form of a rent subsidy and may be provided in the home in which you presently live, subject to program criteria. We will be accepting applications for the Section 8 Rental Assistance Program until 5:00 p.m., June 1, 1987. Any applications submitted after this date will be returned.

In addition to the above program, the Housing Authority will accept applications for the Section 8 Moderate Rehabilitation Program. Unlike the assistance program, there is no opening/closing date; applications are always welcomed.

This program utilizes specific units which have been rehabilitated to bring them up to program standards. Applicants will be offered these remodeled units in Clackamas County according to date applied and bedroom size required. Rent paid by the family will be based upon the household's income.

The waiting list for the Moderate Rehabilitation Program is generally shorter than other waiting lists.

Occupants of and applicants on the present waiting list for public housing and other assisted housing must specifically apply for the Section 8 Rental Assistance Program and/or Section 8 Moderate Rehabilitation Program if you wish to participate.
