## SEWER IMPROVEMENTS

Sealed Bids for the construction of **SEWER IM-PROVEMENTS** in the City of Rainier, Oregon addressed to the Mayor and City Council, 106 B West, P.O. Box A, Rainier, Oregon 97048, will be received until 3:00 p.m. local time on the 28th day of May, 1987 in the City Recorder's Office in City Hall at the above address at which time bids will be publicly opened and read aloud.

The project consists of work under a base bid and additive alternates as follows: The base bid includes construction of approximately 5850 lineal feet of 4, 6, 8 and 10 inch diameter sanitary sewers: approximately 1870 lineal feet of 10, 12, and 15 inch diameter storm drains; 28 manholes; transfer of approximately 80 sanitary sewer services; reconstruction of 315 lineal feet of 33 feet wide street with concrete curbs and paving. The additive alternate work includes construction of approximately 2800 lineal feet of 8, 10, 12 and 15 inch diameter storm drains and 7 manholes. The majority of the work is located within the improved roadway.

Bidders upon returning the Documents, in good condition, within 10 days of the bid opening will be refunded their payment; non-bidders upon so returning the Documents will be refunded \$50.00.

Bidders in doubt as to their qualifications to perform the work are encouraged to contact the Engineer informally to determine if a prequalification request is necessary. Prequalification requests must be submitted no later than 5:00 p.m. on the 14th day of May, 1987.

A Pre-Bid Conference will be held May 14th at 10:00 a.m. beginning at the Rainier City Shops. Test holes will be excavated and a general discussion of the project will take place.

Each Bid must contain a statement by the Bidder that the provisions of ORS 279.350 shall be complied with.

Prospective Bidders are advised that the work is partially funded by a grant from the State of Oregon Intergovernmental Relations Division and that the work will be subject to the prevailing wage rates established by the U.S. Department of Labor and to Equal Employment Opportunity requirements.

Each proposal must be submitted on the prescribed form and accompanied by a certified check or bid bond payable to the City of Rainier, Oregon in an amount of not less than 10 percent of the total amount of the Bid.

The successful bidder will be required to furnish performance and payment bonds in the full amount of the contract price.

The City reserves the right to reject any or all bids or to waive any informalities in bidding. No Bidder may withdraw his bid for a period of 30 calendar days after the opening thereof.
