

TILLAMOOK COUNTY CALL FOR BIDS

LANDFILL CONSTRUCTION - 1987
Bids Due: 10:00 am, June 3, 1987

This project consists of approximately 8000 cubic yards of embankment, 5000 square yards of drainage blanket, 5000 square yards of bentonite clay liner and other related work at the Tillamook Solid Waste Landfill, near Tillamook, Oregon. The landfill is available for inspection by the bidder from 8 a.m. to 5 p.m., Wednesday through Sunday.

The bidder shall submit his proposal on the form furnished by Tillamook County. Specifications and bid forms may be obtained from the Tillamook County Public Works Department, 503 Marolf Loop, Tillamook, Oregon, 97141, (842-3419).

No bid will be considered by Tillamook County unless the bid contains a statement by the bidder that the provisions of ORS 279.350 (Prevailing Wage Laws) are to be complied with.

Before submitting a bid, the Bidder should examine the construction site and the specifications for this project. The Bidder should thoroughly understand the requirements and methods by which payment will be made for the work. Any questions concerning this proposal should be directed to the Tillamook County Assistant Director of Public Works (842-3419).

Sealed bids shall be submitted to: Tillamook County Board of Commissioners, Commissioner's Office, Tillamook County Courthouse, Tillamook, Oregon 97141. Sealed bids shall be submitted by no later than 10 a.m., Wednesday, June 3, 1987. Bids received after this time will be returned unopened. Bids may be withdrawn at any time, prior to opening, upon written request of the Bidder.

Tillamook County reserves the right to reject any or all bids not in compliance with all prescribed public bidding procedures and requirements. Tillamook County may reject, for good cause, any or all bids upon a finding it is in the public interest to do so. The County reserves the right to waive any informality in bids at its discretion.

All bids will be opened and read aloud at the Tillamook County Justice Courtroom, County Courthouse, at 10:15 am, Wednesday, June 3, 1987.
