### VETERINARY ANATOMY POSITION

The Department of Anatomy and Cellular Biology of the Tufts University Schools of Medicine, Dental Medicine and Veterinary Medicine invites applications for tenure track positions. Applicants should possess a Ph.D. and/or D.V.M. degree (or equivalent). At the assistant professor level, applicants should have had at least two years of postdoctoral research experience, show promise of developing an independent research program, and have had some experience in teaching veterinary gross anatomy. At more senior levels, applicants must have an active, funded research program and considerable teaching experience in veterinary anatomy. Major research areas in the Department include: cell and molecular biology, developmental biology, reproductive biology and neuroendocrinology. We especially seek candidates to join a group involved in molecular, cellular and physiological studies of early development in laboratory and domestic animals, and transgenic manipulations thereof. Research in male gamete biology and preimplantation embryology are of particular interest. This group is located at our Veterinary School campus in Grafton, Mass., approximately 35 miles west of Boston. This attractive and spacious campus provides unique opportunities for multidisciplinary research with large and small domestic animals. Salary and rank are dependent upon qualifications and experience.
