# NOTICE OF REQUEST FOR PROPOSALS

The City of Portland, Bureau of Traffic Management, is seeking the services of a qualified consultant or consulting team to develop the 1988 Downtown Parking Plan and Circulation Update. The Plan is intended to remedy deficiencies in data and to develop recommendations for strategies to meet short range and future parking and related circulation needs of downtown Portland within the framework of existing policy.

Required work elements include design, performance and analysis of parking utilization and parker surveys to assess current parking conditions and create profiles for each parking sector within downtown and selected fringe areas; project additional parking demand by type and sector; recommend strategies to meet the demand; reveiw downtown circulation in regard to enhancements related to parking, pedestrian and bicycle amenities; and evaluate parking scenarios for air quality and circulation impacts using the City's air quality offsets and downtown circulation models.

The plan will include proposals that maximize efficient use of existing parking facilities, and will recommend alternatives to downtown parking. The study will investigate whether additional parking facilities should be built or acquired by the City and recommend optimal public facility rate structures.
