Local **Economy** Strong in October

W.E. Hunter, Oregon Employment Divison Administrator, announced that October was an excellent month for Oregon's economy. "Strength was evident in almost all sectors," he said, "with the few negative events linked more to weather conditions than to economic factors.

The seasonally adjusted unemployment rate crept up by onetenth, the fifth straight monthly increase. However, in nine months of decline, the rate fell from 8.6% in August 1986 to 5.5% in May 1987. Since then, a gradual upward movement has raised the rate by less than a full point. Also, the rate would not have risen in October but for the unusual weather conditions. Thus, it becomes apparent that rather than the gradual increase being a cause for concern, the unemployment rate continues to indicate a strong economy.

Results of Oregon's monthly survey of employers show that wage and salary employment has set a new record for the fourth time this year. With 1,120,400 payroll employees, 38,000 jobs have been added in the past 12 months.

Federal Express Given Portland-**Tokyo Small Package Approval**

The Department of Transportation has given Federal Express approval to begin small package shipments to Tokyo via Portland International Airport. The long-awaited decision gives Portland a second air entry into Japan that could represent an annual economic impact to the area of \$25 million.

The decision cited Federal Express' door-to-door service as a key igredient to a successful United States-Tokyo route. It makes Portland the sole gateway for small package shipments between the two countries, a designation that could be significant in Oregon's attraction of new business and in-

Though the decision must be approved by the White House, Federal Express could start their service by summer 1988. A \$5 million expanded cargo facility for Federal Express has already been completed at Portland International Airport to meet the needs of the new service.

Gasoline Prices Higher

The bad news is gasoline prices are continuing to increase. The good news is that the rate of increase is much slower than it has been recently, according to the Oregon AAA Thanksgiving Fuel Gauge

The average price of gasoline increased two cents per gallon between Labor Day and Thanksgiving, compared to an increase of seven cents per gallon between the Fourth of July and Labor Day.

Over the Thanksgiving holiday, full-servie cash customers will pay an average of \$1.04 per gallon for regular gasoline, \$1.08 unleaded and \$1.20 for super unleaded.

At the mini-service pumps, average prices will be 85 cents per gallon for regular, \$1.00 for unleaded and \$1.11 for super unleaded.

The average price of gasoline is 13 cents per gallon higher than it was in Thanksgiving 1986, according to survey figures.

A small majority of stations -54 percent - will be opened during the Thanksgiving holiday. An even smaller number - 17 percent - will be open 24 hours a day through the holiday period.

PGE Offers Emergency Fuel Assistance

Thousands of Oregonians will stay warmer this winter thanks to Project HELP, a one-time emergency fuel assistance program administered by The Salvation Army.

For the sixth consecutive year, Portland General Electric Co. (PGE) is asking customers to join with them in contributing to Project HELP. The program is intended to assist people who are not eligible for the Low-Income Energy Assistance Program (LIEAP) administered by the state.

Kay Stepp, President of PGE's Energy Services Division, presented a \$40,000 shareholders' check to The Salavation Army to kick off the program in PGE's service area. The .corporate donation is a startup fund for Project HELP.

"Last year PGE customers, employees, and shareholders contributed \$320,158 to Project HELP," says Roberta Andrus, PGE Consumer Assistance Representative, Portland. "This made it possible to provide an average of \$108 to 3.061 families throughout our service area."

PGE customers with a monthly income between 125 percent and 150 percent of the federal poverty guidelines are eligible for Project HELP assistance. For a family of four, monthly income cannot ex-

ceed \$1,375. "We are proud to be part of Project HELP because we know that through our customer, shareholder, and employee efforts, many needy people will make it safely through the cold winter," Andrus says. "Since 1982, PGE's total donation of \$1.5 million to the project has helped more than 15,000 Oregon-

Donations to Project HELP go directly to The Salvation Army, which screens applicants and disburses funds to customers' fuel suppliers, regardless of the fuel

PGE customers are receiving special Project HELP donation envelopes in their winter billing state-

"Customers who wish to make a tax deductible contribution to Project HELP should write a separate check for their donation and not add it to their regular utility bill payment," Andrus says.
