#### MINORITY BUSINESS **ENTERPRISE PROGRAM POLICY STATEMENT**

It is the policy of the Port of Portland Commission, through a commitment to the minority and women business enterprise community, to establish goals whereby minority- and women-owned firms have the opportunity to participate in Portwide and airport construction contracts, professional and other services, and procurement, and are given the opportunity to bid on airport concession leases and service contracts; and

The objective of the fiscal year 1988 Minority Business Enterprise Program is to stimulate minority business enterprise participation in the Port's competitive bidding process, procurement, and airport concession leases and service contracts; and

That such a program consists of:

- 1. A goal of 10 percent participation by minority business enterprises and 3 percent participation by women-owned enterprises in Portwide con-
- 2. A goal of 10 percent participation by minority business enterprises and 3 percent participation by women-owned business enterprises in federally funded airport construction contracts costs.
- Efforts to solicit the interest of minority and women businesses in professional and other services, and procurement. .
- Maximum opportunity for minority- and women-owned firms to participate in the concession and consumer service agreements at Portland International Airport. A goal of 3 percent MBE and 0.5 percent WBE participation is established for concession and consumer service agree-
- Distribution of contents of the program throughout the Port offices, minority and nonminority communities' business organizations and publications, and prime contractors.
- Designation by the Executive Director of a liaison officer with full responsibility to organize the program and coordinate efforts with the Port management to ensure the success of the program through accomplishment of the above-stated goals.

The Port will evaluate and adjust the substance of the program annually.
