FINANCIAL ASSISTANCE AVAILABLE TO BUSINESS

Financial Programs are available to Oregon businesses through the Oregon Economic Development Department.

- **The Oregon Business Development Fund loan program.** The Oregon Business Development Fund is a direct loan program, designed to provide fixed rate, long-term subordinated financing for business expansion. The purpose of the loan program is to provide financing for land, buildings, fixtures, machinery, and working capital for eligible activities. Eligible activities generally include manufacturing, distribution and processing. Fifteen percent of the money in the fund is reserved for loans to women and minority entrepreneurs.
- **The Oregon Economic Development Corporation.** The Department will assist in loan packaging for small and medium sized companies seeking financing through the Federal Small Business Administration "504" loan program. The 504 program provides long-term, fixed rate financing for fixed asset business expansion.
- **The Industrial Development Revenue Bond (IDRB) Program.** This program provides a method of lowering the cost of financing for larger business expansion. Eligible activities generally include fixed assets for manufacturing and distribution.
- **The Composite Revenue Bond Program.** This program will be available within the next two months. It is primarily designed to provide fixed asset financing for small to medium sized companies, with the same eligibility requirements as IDRB's.
