## A.M.A. Teen-Parent Project

Few roles are as unenviable as that of being a teenage mother. Yet there are three new teenage mothers every day in Multnomah county alone, and the numbers are growing. In the midst of this growing problems stands a dedicated group of people who make up the Albina Ministerial Alliance's (A.M.A.) Teen Parent Project.

The Teen Parent Project, now entering its 4th year of operation, served approximately 50 teen parents last year. Their assistance was broad and included; day care programs to help mothers get their high school degrees, support and education programs, clothing and other services aimed toward alleviating some of the tremendous burden of being a teen mother.

This program has been successful through a combination of volunteer labor and dedication by its staffed personnel. Ms. Kay Molden recently replaced Cornetta Smith as program director and has inherited the fine services of Cordella Hopson, Information and

Referral Coordinator, Lanita Duke, case manager and Elbert Mondane who concentrates on work with teen fathers.

According to Cordella Hopson, there are many needs for the upcoming year. As always, people who are interested in volunteering time and/or labor can contact the program at 285-0493. Another need involves an incentive program to help parents to attend support groups and other programs. The program is asking for donations of gift certificates to stores in the Portland area. As always, there is a need for additional funding for many of the services that the program offers, such as transportation, clothing and day care. And finally, they are looking for teenage parents to serve in the upcoming school year.

Thurston Regional Planning Council (TRPC) is the Council of Governments for the jurisdictions within Thurston County. TRPC does land use, environmental, transportation & other planning programs. TRPC is the state-designed Metropolitan Planning Organization (MPO) for transportation planning. Current transportation programs include metropolitan transportation systems planning (including preparation of the Transportation Improvement Program, data base management, travel forecasting, transit planning & grant administration) rail transportation planning, review of development projects & special studies.

Thurston County has a metropolitan area pop. of 90,000 with total population of 150,000. The County is located at the south end of Puget Sound, 60 miles south of Seattle.

This is a highly responsible position with project management responsibilities for transportation systems planning & Administration. Major components of this position include policy development & analysis & transportation modeling. Experience with MicroTRIPS, UTPS, EMME/2, T-Model or other travel forecasting models, is required. This position also involves overseeing transportation consultants & participating in environmental (SEPA) review for development projects. Other desirable experience includes transit, bicycle, pedestrian & special transportation studies.

Currently the transportation program is staffed by this planner only. Due to growing interest & increasing demands on the transportation system, we anticipate expansion of the program in the future.
