# **Correctional Officer Recruitment**

The Oregon Department of Corrections is currently recruiting for Correctional Officers. Openings currently exist in Salem at the Oregon State Penitentiary, Oregon Women's Correctional Center and the Oregon State Correctional Institute. In Pendleton, openings currently exist at the Eastern Oregon Correctional Institution. The Correctional Officer's main duty in these facilities is to supervise and control inmates to maintain security and enforce discipline.
