QUESTIONS AND ANSWERS For Social Security or Supplemental **Security Income Assistance**

QUESTION: My wife has been receiving Social Security benefits for four years. Every summer she works for a berry farmer and earnings even though the small earnings don't increase her benefits. Why does she have to pay taxes on these earnings?

ANSWER: Agricultural employers, farmers and farm crew leaders are required to pay Social Security taxes on most farm workers. If your wife does agricultural labor for an employer who pays out \$2,500 or more in cash wages during a year or who pays out less than \$2,500 but pays her, or any other worker, \$150.00 or more, she will have to have social Security taxes withheld from her wages. The taxes may not help her get a higher benefit, but they will help ensure the continuation of benefits to her and future social

QUESTION: I am hard of hearing, but not totally deaf. I tried to contact SSA through the deaf toll-free number and couldn't get anyone on the line. How does that number work?

ANSWER: We may have misled you in a previous Question & Answer column. The deaf toll-free number will only work for people who have a telecommunications device for the deaf, a T.D.D. You can learn how to get a T.D.D. by calling 1-800-848-4442 or by writing to the Labor and Industries Building, Salem, OR 97310.

QUESTION: When I got married, I was contacted by a company called Official Record Service in Nevada. They told me I needed a new Social Security card and that they would get me a card for \$10.00. This is the first time I was ever charged for a Social Security card. Has there been a change

ANSWER: Social Security does not charge for new or replacement cards. There are several companies that get lists of marriages and births and then contact the individuals to offer them help, for a fee, in getting a card. Usually their letters look very official, so some people send the money. The company just sends the person a Social Security form, or a copy of one, to complete. We at Social Security will provide the same service at no charge.

QUESTION: Am I automatically covered for Medicaid when I file for Supplemental Security Income (SSI)?

ANSWER: Not in Oregon and certain other States. Entitlement to Medicaid is not always automatic. If you live in a State that has an agreement with Social Security to make Medicaid eligibility determinations, your SSI application would serve as an application for Medicaid. However, since Social Security does not make Medicaid eligibility determinations in Oregon, you will have to apply at your local welfare office.

QUESTION: Now that I have Medicare catastrophic protection, what effect will this coverage have on my Medicare supplemental policy? I'm wondering if I should continue the supplemental policy?


ANSWER: Medicare Parts A and B provide coverage for basic health care costs, but neither pays for all medical expenses for all long term care. Therefore, if you want more complete health care coverage, you might consider comparison shopping and selecting a supplemental policy. But remember, starting in 1990, Medicare catastrophic coverage begins paying covered medical insurance benefits only after your health care expenses under that part of Medicare exceed \$1,370. A Medical policy would, therefore, help pay for part of those expenses incurred during the interim. For answers to specific concerns, contact your private insurer and your Medicare carrier.

QUESTION: I would like to check to be sure my earnings have been correctly reported to my social Security record. Can I use the toll-free

ANSWER: Yes. Just dial 1-800-234-5772 and the operator will arrange to send you a Request for Earnings and Benefit Estimate Statement to complete and return to Social Security. In response, you will receive a detailed record of your earnings, quarters of coverage information, and estimates of what you and your family will be due at your retirement, or your death, or should you become disabled.


