Dr. Fulani To Speak At PCC Sylvania Campus In Celebration Of Black History Month

Willamette Industries Donates \$75,000

For New Boys & Girls Club

In celebration of Black History Month, Dr. Lenora Fulani -- a 1988 and 1992 Presidential candidate--will be speaking at Sylvania Campus PCC, 12000 SW 49th. The event is scheduled in the Cedar Room, off the main cafeteria of the C.C. building, Thursday, Feb. 15th, from 11:00 a.m. to 1:00 p.m.

The national chairperson of the controversial New Alliance Party, Dr. Fulani made history in 1988 when she became the first woman and the first African-American candidate for the Presidency of the United States ever to be on the ballot in all 50 states and the District of Columbia. She is also the first Black woman ever to qualify for federal matching funds.

Portland Teacher Wins Apple Computer Contest: Four Oregon Winners Are Recognized

CUPERTINO, CALIF .-- Edith A. Murray, a teacher at Prescott School in Portland, Ore., is the winner of a Macintosh SE/ 30 computer system, having won first prize in the Macintosh Education Solutions Competition for K-12 educators. The contest, sponsored by Apple Computer, Inc. Northwest Operations, was held to recognize and reward innovative education solutions created for use on the Macintosh computer by teachers in more than 11,500 schools in the Northwest.

Murray won the prize for developing a Macintosh computer-based program for elementary school libraries entitled "Bookmark," a directory of children's literature. She was one of four Oregon winners.

Other Oregon winners included: Ariel Paisley, Whitford Intermediate. Beaverton; Thomas Layton, South Eugene High School, Eugene; and Jim Crotts of Sweet Home. Paisley was awarded first prize for lesson plans in the middle school category, and Layton was recognized for a program for administrators. Crotts received honor-

Cuban-Born Pianist Santiago Rodriguez Performs Beethoven's Piano Concerto No. 1 With Oregon Symphony

Santiago Rodriguez-the Cuban-born pianist who won the Silver Medal at the 1981 Van Cliburn International Competition-will perform with the Oregon Symphony at the Arlene Schnitzer Concert Hall. Performances are scheduled for Sunday, Feb. 11 at 7:30 p.m., and Monday and Tuesday, Feb. 12 and 13, at 8:00 p.m.

Under the direction of Oregon Symphony Maestro James DePreist, Rodriguez will perform Beethoven's Piano Concerto No. 1 in C Major. On the second half of the concert, the Oregon Symphony will perform Mahler's Symphony No. 10 in F# Major (Deryck Cooke version). The performance marks an Oregon Symphony premiere of the Mahler work.


