Contractors and subcontractors who intentionally fail to post the PWR can be made ineligible to receive any public works contract for up to three years.

RECIPROCAL PREFERENCE LAW: In compliance with ORS 279.029, bidders must state on their proposal whether they are a resident or nonresident bidder. Proposals that fail to provide this information will be considered nonresponsive.

Sealed bids are requested for labor and materials to rehabilitate single family residences located at scattered sites in Portland, Oregon. The work is divided into two component parts, PART A consisting of 17 vacant houses located in north and northeast neighborhoods, and PART B consisting of 6 vacant houses located in southeast and outer northeast neighborhoods. Shortly thereafter, bids will be opened and publicly read. The attendance of bidders is welcomed. Interested Bidders may bid on either PART A or B, or on both parts.
