Several members of Portland City Council have received letters and telephone calls protesting the appearance of Andrew Dice Clay at Arlene Schnitzer Hall, February 15th. Citizens have contacted our offices to complain about the racist and sexist messages contained in Andrew Dice Clay's "humor".

Andrew Dice Clay has come under fire nationally, for his "jokes" which trivialize and make fun of violence against women, people of color and children. His brand of "humor" is seen as helping to perpetuate attitudes of racism, sexism and violence against all women, all children and all people of color.

As members of the City Council, we support the First Amendment rights of all Americans, including Andrew Dice Clay. We do not support racism, sexism and humor based on violence against people because of race, gender, sexual orientation, ability, age, or national origin. Because we in Portland are concerned with the well being of all of our citizens, we must raise our voices in protest against "entertainment" which perpetrates negative attitudes and stereotypes. We take seriously our responsibility to speak out against bigotry in any form and in meeting this responsibility we denounce those who would benefit financially from the dehumanization of women, children and people of color.

We urge Portlanders not to go to the concert. We ask you to turn in your tickets. We ask that you refuse to economically reward those who try to make a living off of hatred and violence.


