Beta-carotene is a nutrient touted in numerous medical reports which suggest that populations which consume foods rich in beta-carotene have a lower risk of developing certain types of cancer. Citrus, until recently, has not been considered to be a good source of beta-carotene. Studies have also shown that beta-carotene can reduce the risk of strokes and heart attacks.

Three years ago, California-based Sun World International introduced its Star Sweet grapefruit to distinguish its premium California Star Bury and Rio Red super-red grapefruit varieties. These super red varieties are the latest varieties in the continuing parade of redderfleshed grapefruit. The Indio-based firm is now California's largest grower and marketer of both super-red varieties, which were developed by Texas A & I

citriculturalist Dr. Richard Henz.

Sun World International is currently harvesting these special grapefruit from orchards in southern California; they are packed at the company's Irvine, Riverside and Coachella facilities. Star Sweet are considered to be sweeter, juicer and more flavorful than Golden (white) or Ruby (pink) varieties, and have a deeper red coloring than the Ruby Red variety.

In addition to being a rich source of beta-carotene, grapefruit are an excellent source of vitamin C, providing at least 50 percent of the recommended daily allowance as prescribed by the Food and Nutrition board of the National Academy of Sciences. They contain no cholesterol and are naturally low in calories, fat and sodium.

The Physicians Health Study, a 10-year on-going study and one of the largest studies to test the long term effects of beta-carotene on cancer and heart disease, also recommend carrots, sweet potatoes, yellow squash, spinach and kale as foods rich in beta-carotene.

### Senior's Property Tax Deferral **Application Period**

Property tax deferral applications for lower income senior citizens should be filed with county assessors between now and April 15, reminds the Department of Revenue. Oregon homeowners age 62 or over who meet all the requirements may delay paying property taxes on their residences. The taxes must eventually be paid, with interest, when the owner dies, moves, or sells the

'Applications are available at your county assessor's office. If your application is approved, the State of Oregon will pay your property taxes for you. Once you have been accepted into the

program, you don't have to apply for the following years. The deferred taxes paid by the state become a first lien on your property, except for the liens of mortgages or trust deeds that were recorded before the deferred taxes.

To qualify for the deferral you must meet the following requirements: \* You must be 62 years old by April 15 of the year in which you file

and implemented by the Task Force. It seemed natural to suppose that these points were drawn from the successful experiences of those 22 nationally-acclaimed urban educators detailed in the book, Partners for Success: Business and Education (These were the principals from urban districts around the nation who were welded into an organization by Ron Herndon; The National Association for Schools of Excellence).

Most of these people were angry or confused, and made comments to the effect that they had purchased "the book" and videotape after reading favorable articles. "We spent a lot of time examining this material and we were favorable impressed with real world, proven techniques. Several of us have even written some of these successful educators of poor and minority children for advice that would help us achieve these remarkable results in our own community. Were we naive in sharing these thoughts with our P.T.A., cluster groups and others?"

I could not furnish much of an answer since I have heard nothing from the "Excellence" group in months. Obviously, this is not likely to satisfy people who, for one reason or another, were in my face shouting, "This com-

ture, coherence and continuity, since the Acknowledgements Page of the book listed the region's top educators, industrialists and foundations." Several frustrated persons have vowed to call people or organizations listed on that illustrious roster.

Now, for what appears to be everyone's fly in the ointment, that ephemeral "Idaho Education Project." This concept being as new to the Observer staff as anyone, we asked an official at the school district for clarification, "It is a proposal for a statewide overhaul of Idaho's education system, one designed to prepare their students to meet international competition BY THE YEAR 2000. which the Bureau of Labor and Industries has the responsibility to enforce. I strongly endorse the law as I consider it to be pro-family and pro-business.

As important as the law is, it is not enough. I have submitted a Family Medical Leave Bill, Senate Bill 39, which would grant up to 12 weeks of unpaid leave to deal with seriously ill children or other family members. The importance of addressing this type of leave is

Balancing work and family responsibilities is difficult because everyone thinks it is someone else's problem. Former Secretary of Labor Bill Brock stated, "We still act as though workers have no families. Secure parents who aren't worried about their kids are better workers."

It is clear that working parents feel a strong need for societal supports, a need which thus far has not been met in many areas.

The real conflicts between work responsibilities and family responsibilities must be addressed through realistic personnel policies.

As the labor force changes in nature and shrinks in numbers during the next decade, a business priority will be attracting and retaining skilled employees as well as maximizing labor productivity. To do this, business must plan for, anticipate and accommodate this changing workforce because it's the reality of our future in America.

In a nationwide survey of 10,000 business executives, the U.S. Small Business Administration found that the costs of permanently replacing an employee far exceed those of granting a worker's request for a leave-demonstrating that family and medical leave may actually reduce costs to business. It found that termination costs, recruiting and training replacements, lost output and productivity during the transition, and severance packages cost an employer anywhere from \$1,131 to to \$3,152 per terminaton. Average costs for and employer providing leave ranged from \$.97 to \$97.78 per week of leave.

Family Medical Leave recognizes Oregon's and the nation's startling shift in demographics. It recognizes that reconciling family needs with the demands of the workplace means more productive workers. It recognizes that recruiting and retaining valued workers is a priority for business. And it recognizes the important role of family in our society.

It is in everyone's best interest to remove impediments to productivity in the workplace. The end result will be a stable workforce that is productive and a society that puts its money where its heart is, when it comes to the wellbeing and happiness of the family.

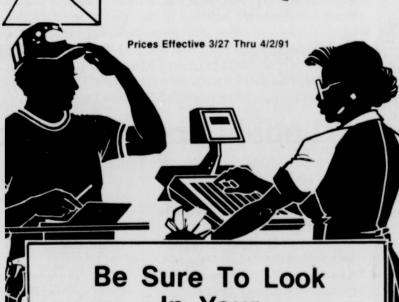
