The City of Salem will receive sealed bids at the office of the City Recorder, City Hall, Room 205, Salem, Oregon until, but not after 11:00 a.m., April 17, 1991, at which time said bids will be publicly opened and read aloud in the City Council Chambers, Room 240, 555 Liberty Street S.E., Salem Oregon for the project specified herein.

The proposed work consists of: Approximately 420 linear feet of 9-foot wide paved shoulder/pedestrian walkway, 210 linear feet of (mountable) asphalt curb, 15 linear feet of concrete curb sidewalk, 3 catch basins, 180 linear feet of 10-inch storm drain, pavement striping, and appurtenant work.

Every contractor or subcontractor is required to post the applicable Prevailing Wage Rates (PWR) in a conspicuous and accessible place in or about the work-site for the duration of the job. Contractors and subcontractors who intentionally fail to post the PWR can be made ineligible to receive any public works contract for up to three years.

Proposals that fail to provide this information will be considered non-responsive. The City of Salem reserves the right to reject any or all bids, to waive formalities and of postponing the award of the contract for thirty (30) days.


