Eastman Parkway, Gresham, Oregon 97030, until Wednesday, August 7, 1991, 10:00 a.m., Pacific Standard Time, at which time they will be opened, for the construction of the MID-COUNTY N.E. 188TH, 191ST AND GLISAN COLLECTOR SEWERS, PROJECT NO. 3048.

The major quantities involved are as follows: Project No. 3048: L.F. 1800--10" Gravity Sewer Pipe; L.F. 5500--8" Gravity Sewer Pipe; L.F. 700--6" Gravity Sewer Pipe; L.F. 4500--4/6" Service Lateral Pipe; Each 27--Manholes.

Contractor for this work shall furnish all labor at current U.S. Department of Labor prevailing wage rates, materials and equipment and services of all kinds to complete the work in accordance with the plans and specifications therefor.

Contractors must prequalify for sanitary sewer construction with the City of Gresham, as required by the laws of the State of Oregon, before the date of a bid opening. Otherwise, their proposals may not be given consideration.

In determining the lowest responsible bidder, the public contracting agency shall, for the purpose of awarding the contract, add a percent increase on the bid of a nonresident bidder equal to the percent, if any, of the preference given to that bidder in that state in which the bidder resides.

Each bid must contain a statement by the bidder that the provisions of ORS 279.350 will be complied with. Each bidder must file with his bid an affidavit of non-collusion. An orientation will be given prior to moving to the project site. Questions posed during the tour, when not addressed in the specifications, will be answered by addendum and mailed to all bidders.

Attention is called to the provisions in "Supplemental Instructions to Bidders" regarding MBE participation and Division "H," "Special Conditions," regarding Equal Employment Opportunity, EEO compliance reports, certification of non-segregated facilities and a waiver from enforcing the payment of non-federal prevailing wages when said wages, exclusive of any fringe benefits, exceeds the applicable wage rate determined by the Secretary of HUD.

Environmental Assessments and Findings of No Significant Impact

for the
North Transit Mall Extension,
North Terminal Facility
and
Tigard Park and Ride Lot

Notice is hereby given by the Tri-County Metropolitan Transportation District of Oregon (Tri-Met) that separate Environmental Assessments for the North Transit Mall Extension, the North Terminal facility, and Tigard Park and Ride lot projects are available for public review.

The North Transit Mall project consists of final design of the extension of the existing transit mall on NW Fifth and Sixth Avenues north from West Burnside Street and including NW Irving Street. Proposed improvements include sidewalk widening, narrowing of the street to one bus-only lane and one auto lane which could also be used for bus passing, and installation of passenger shelters, lights and landscaping. Several mitigation measures are identified in the environmental assessment which are conditions of federal grant participation in the project.

The North Terminal facility will provide an off-street layover area north of Burnside Street, allowing for bus staging in conjunction with the transit mall. The project is proposed for a partial block bounded by NW Fifth, NW Hoyt, and the railroad tracks. The majority of the site will be paved for bus parking. A driver break area including restrooms, a passenger waiting area and landscaping are also planned for the site. Two mitigation measures related to reconstruction of Hoyt Street and visual aesthetics are included in the environmental assessment and are conditions of federal grant participation.

The Tigard Park and Ride project includes final engineering and construction of a potential 200 space lot off SW 74th Avenue and Pacific Highway 99W. One water quality mitigation measure is included in the environmental assessment and is a condition of federal funding.

The Urban Mass Transportation Administration has issued a Finding of No Significant Impact for each of these projects.
