The purpose of this request for Proposals is to provide the basis for selecting a qualified and experienced person/firm to assist the City with the programming, planning and construction of a high quality, functional, low maintenance and attractive Public Safety Facility for the City of Milwaukie.

The selected person/firm will be responsible for the design of interiors and the development of the surrounding property, including utilities, landscaping, ingress and egress, and parking. The selected person/firm will work closely with the City from the early design phase of the project to the Public Safety Facility construction and completion.

SELECTION PROCESS

The City contemplates a two-stage selection process. The first stage is to solicit and review examples of work done on similar projects. The second stage will involve a more intensive exploration of selected respondents' ability to accomplish the project compo-

In the interest of a fair and equitable selection process, the City of Milwaukie retains sole responsibility to determine the timing, arrangement and method of proposal presentation throughout the
