Disadvantaged Business Enterprise (DBE) Supplemental Required Contract Provisions Amendments Affecting DBE Participation on ODOT Highway Division (Federal Aid) Construction

#### Projects.

Effective November 1, 1991, the following changes have been made to the Supplemental Required Contract Provisions Disadvantaged Business Enterprise Program:

#### **SECTION 4, Paragraph 11 NOW READS**

The contractor may work with a DBE service provider to obtain needed materials, supplies, equipment, transportation, personnel, bonding, or insurance to perform a contract or program function. The contractor may count toward its DBE goal only the portion of the amount paid which constitutes the fee or commission to be received and retained by the DBE provider for the service rendered.

#### **SECTION 5, Paragraph 2 NOW READS**

Bidders shall complete and submit with the sealed bid DBE Participation Commitment form No. 1, included in the Bidder's Proposal, listing the name, address and value of work committed to each DBE subcontractor, lessor, manufacturer, supplier of service provider to be used on the project should the bidder be awarded the contract. Section 4 of these Supplemental Required Contract Provisions discusses the percentage of DBE participation which counts toward the bidder's goal for various types of firms. Bidders shall also compute the bidder's DBE participation commitment percentage, as instructed in Form No. 1, Part I(E). DBEs who are bidding as prime contractors must also meet the assigned project goal, and may not count their own participation toward achievement of the DBE contract goal. DBEs bidding as prime contractors must provide opportunities for participation by other DBEs, and must therefore abide by all requirements for documentation of DBE participation.

#### **SECTION 7, Paragraph 5 NOW READS**

(b) If the low bidder offering a reasonable proposal has not met the assigned goal, i.e., the bidder's DBE participation commitment percentage is less than the project's assigned contract goal, the Division will review the documentation regarding the good faith efforts made and the affirmative action steps taken, submitted in accordance with DBE participation Commitment Form No. 1 Part II, and will determine if the steps taken are satisfactory. As a result of the review, if the affirmative action steps taken are satisfactory, that bidder will be recommended for the contract award. If the steps taken are not satisfactory, that bidder will be considered nonresponsive.

Contractors are encouraged to familiarize themselves with the amended provisions when preparing their bid proposals. Questions regarding the changes should be directed to the ODOT Civil Rights Section at 378-8077.


