# HUD Announces First Ever Waiver To Help Employees Qualify For FHA Loan Program Emanuel Grants Its First ENHOP Loan to Employee

Representative Ron Wyden announced today that in enterprise zones around the state, the Housing and Urban Development office (HUD) will waive the 5 percent down payment required from a homebuyer's own funds to only two percent, allowing the remaining three percent to be supplemented by an employer loan program.

The first approval of its kind in the nation, the waiver comes on the heels of a new program at Emanuel Hospital & Health Center and Legacy Health System that loans employees up to \$5,000 to buy a home in Emanuel's immediate neighborhoods. Legacy's program stimulated this HUD waiver.

"Normally this type of program is not permissible with an FHA loan," said Tom Cusack, HUD Director of Housing Development Division," But we are willing to take an additional risk in exchange for investment in enterprise zones."

According to Cusack, enterprise zones are areas created by the State Legislature in an attempt to encourage re-investment in business and housing development. In Oregon, there are 30 enterprise zones, North and Northeast Portland being one of the most populated

The change in policy by HUD has allowed Emanuel to grant its first Emanuel Neighborhood Home Ownership Program (ENHOP) loan. Starla McCuller, 43, is the first Legacy Health System employee to see the dream of owning a home become a reality. "It's too good to be true," she said. A social worker for the Oregon Burn Center at Emanuel, McCullar has had her perceptions changed about North/Northeast Portland. "When I first started



working at Emanuel, I had some concerns," she said," but I've met a lot of people who live in the area and I think, overall, parts of this area are really nice."

McCullar said she bought the home, located just off of Portland Blvd., primarily for the neighborhood. "I was quite taken by it," McCullar said. "I looked around a lot and in this neighborhood people help each other out," she said, "It reminds me of where I grew up."

"What Emanuel's program has allowed me to do is have a little of the American Dream," said McCullar. "The ENHOP program can only benefit the employees and neighborhoods," she said, "It's innovative and wonderful."

All employees of the Legacy Health System who qualify may apply for an ENHOP loan. The third largest private see its significance as other employers institute programs for their employees," he said.

Emanuel has stated that they will make the materials used to create the ENHOP program available for other employers to adopt.

"This is a model program," said Cusack, "but the only way it can truly be successful is for other employers to become involved. As other enterprise zone employers become committed, we will see the difference the HUD waiver will make state-wide."

The HUD waiver carries sign significance that may even influence other cities in the nation to begin similar employee-assisted loan programs.

In addition, Fannie Mae, a private company chartered by Congress to provide a national secondary mortgage market, has named ENHOP as the first employer-assisted homeownership program in the state to be approved for their Magnet 3/2 program. This program allows for three percent down from the buyer's funds and the balance to be provided by an employer loan.

"Fannie Mae is delighted to be part of this new plan to enable the employees of Emanuel Hospital to afford homeownership near their work place, and at the same time, revitalize the Portland community surrounding the hospital," said John Fulford, senior vice president in charge of the company's 10-state western regional office.

He went on to add, "This is exactly the kind of effort Fannie Mae Chairman Jim Johnson had in mind in March 1991 when he announced a special \$10 billion corporate commitment to special needs and low-to moderate-income housing nationwide."

### OSU, NAACP Collaborate On Scholarship For Ex-Inmates

Oregon State University and the Corvallis-Albany branch of the National Association for the Advancement of Colored People have established a new scholarship fund to benefit former inmates of the state Department of Corrections.

Officials of OSU's College of Liberal Arts and the NAACP believe it is one of the first scholarships of its kind in the U.S.

The Benjamin L. Hooks Scholarship Endowment Fund--named in honor of the recently retired national executive director of the NAACP--is designed to assist former inmates continue their education, according to Earnestine Berkey, president of the Corvallis-Albany NAACP branch.

Applicants must be former clients of the Department of Social Services; should have families with children; and should have been enrolled in education or vocational training programs with the Department of Corrections.

At the time scholarship funds are paid out, recipients shall be enrolled as full-time students at OSU, and classified at least as sophomores. Scholarship recipients will receive \$500. Sponsors say the recognition is more important than the amount.

"This says to the recipients that 'we have faith in what you are trying to do' and hopefully will show them a sense of trust," Berkey said. "To a college student, especially a former inmate with a family, \$500 can be pretty important."

The College of Liberal Arts is handling counseling and supervision of scholarship recipients, said Harold Hunter, director of development for the college.

"We think this an exciting idea and we hope it will capture the imagination of people around the state," Hunter said.

The Department of Corrections will help identify candidates for the scholarships, which will be funded primarily through efforts of the NAACP, Hunter said. Representatives of the Corvallis-Albany branch of the NAACP will make the final decisions about scholarship recipients, who will be chosen from a list approved by OSU and the Department of Corrections.

Fundraising will begin immediately for the Benjamin L. Hooks Scholarship Endowment Fund, which has been established with the OSU Foundation. For more information, contact Harold Hunter at the College of Liberal Arts, 737-4587.

### City Council Endorses Kafoury's Livable City Project

The Portland City Council adopted a resolution on March 4, 1992, supporting the Livable City Project: Managing Portland's Growth. The project, introduced by Commissioner Kafoury and supported by the Portland Planning Commission, is designed to implement Portland Future Focus goal of capturing a larger share (20%) of the region's projected growth without destroying the cohesiveness and character of existing neighborhoods. "This project will test the theory that we can make neighborhoods safe and stable by building upon the historic characteristics of neighborhoods as they developed along trolley lines," explains Commissioner Kafoury. "We are seeking the input of residents throughout the city to determine how to accommodate growth and

enhance our city's livability," she added.

The Planning Bureau will be in charge of the Livable City Project, coordinating citizen involvement and other city bureaus. Planning Director Robert Stacey is candid about the challenges of this project. "We have more light rail

coming and with it some redevelopment opportunities for housing, retail, and employment," Stacey noted.

"It's time to test some land use concepts for accommodating more people inside Portland instead of allowing all of the growth to occur in the suburban fringe," he added.

There are three main components of the Livable City Project:

 Engage the community in a citywide discussion of the growth concepts.
 Coordinate with other projects related to growth and development such

as Metro's Region 2040 Study.

3. Tie a number of other planning projects into a consolidated effort including updating the land division code, meeting the requirements of the state transportation rule, reassessing application of site and design review, reviewing tree preservation strategies and development on steep slopes, and preparing an infill/redevelopment analy-

Weeks held a hearing on the proposed merger in Medford on January 23. Nearly 100 affected people attended the hearing, and while some asked for clarification of the terms of the merger, all were supportive of the merger. Weeks' decision to approve the merger followed a thorough consideration of the following issues: the legality of the merger; its affect on policyholders or shareholders; the quality of service to be provided under the agreement; and its affect on competition.

The merger is next subject to approval by the corporate member of BCBSO and the physician members of RVPS. If those parties approve the merger, Weeks will then issue a certificate of merger and acquisition, RVPS would effectively cease to exist and BCBSO would takes its place on April 1.

The merger was initiated by RVPS which was concerned about rising health care costs. The company felt that it could best protect its policyholders by merging, while it was healthy, with a large insurance company.

### Century Products Recalls Swings

Century Products Company, Macedonia, OH in cooperation with the U.S. Consumer Product Safety Commission (CPSC) is voluntarily recalling its 1991 model wind-up infant swings with the "Whisper-Wind" motor. Century has received 31 reports of injuries to consumers involving these swings. Most injuries were to consumers who were attempting toopen the motor housing or repair swings that had stopped working.

If the plastic cover over the swing motor is removed, the powerful, coiled wind-up spring will unwind rapidly and forcefully and may cause serious injury. Injuries reported to the firm include puncture wounds and lacerations requiring immediate medical treatment.

The recall applies to approximately 181,000 Century "whisper-wind" infant swings manufactured during 1991. The five swing models involved were sold for about \$30-\$80 nationwide (model numbers: 12-319, 12-329, 12-344, 12-345, and 12-349). Recalled units bear manufacturing date codes 9101 through 9112. The date codes are located on a white label on the bottom of
