The Oregon Department of Transportation, Transportation Development Branch, Future Technology Research Unit, is seeking proposals from consulting firms.

This RFP is to obtain a consultant to run a turn-key operation for a Port-of-Entry Advanced Sorting System (PASS) operational test. This project will demonstrate the feasibility of using mainline weigh-in-motion (WIM), automatic vehicle identification (AVI), on-board computers (OBC), and two-way communication systems to sort heavy vehicles in both lanes of the mainline highway at highway speeds. The operational test area is on interstate 5 northbound by the Ashland port-of-entry.
