Retired Air Force General Benjamin O. **Davis Presented Congressional Black** Caucus' Lifetime Achievement Award

WASHINGTON, D.C. - Retired Air asking that I accept the award for him.' Force Lt. Gen. Benjamin O. Davis, Jr., commander of the legendary Tuskegee Airmen of World War II, was honored recently with the Congressional Black Caucus Foundation's (CBCF) Lifetime

Achievement Award. He was one of six Americans to receive the CBCF's highest honors during the Foundation's 22nd Annual Legislative Weekend Awards Dinner at the Washington, D.C., Convention Center.

George L. Knox III, Vice President, Public Affairs, Philip Morris Companies Inc., whose father served under General Davis, accepted the award for the retired general, who was ill.

"General Davis is an extraordinary man," Knox told the dinner guests. "His mission was to fight fascism abroad and racial intolerance back home. He has honored me greatly in

An infantry officer following his graduation from West Point in 1936, Davis became the first "Tuskegee Airman" to earn wings at Tuskegee Army Air Field in 1941. He subsequently commmanded Black fighter and bomber units that distinguished themselves in battles against German forces in North Africa and in Europe.

General Davis became the first African American Air Force General and was commander of the 13th Air Force, headquartered at Clark Field in the Philippines, before he retired in 1970.

The award to General Davis was a part of the Foundation's commemoration, sponsored by Philip Morris Companies Inc., honoring all living Tuskegee Airmen.

Executive Director of the NAACP; Lane Kirkland, President, American Federation of Labor and Congress of Industrial Organizations; Mary Hatwood Futrell, President, World Confederation of Organizations of the Teaching Profession; Jackie Joyner Kersee, 1992 Olympic Heptathalon Gold Medalist and "the world's greatest female athlete," and Earvin "Magic" Johnson, basketball superstar with the Los Angeles Lakers and 1992 Olympic Gold Medalist.

Philip Morris, for the second straight year, underwrote the cost of works of art by renowned sculptor Ed Dwight, which were presented as awards to the honorees. The works - "Evolution of a People" - depict the move by African Americans from "slave ships and cotton fields to court rooms, classrooms and the halls of Congress.'

The Awards Dinner ended a four-day series of events whose theme was 'Evolution of a People: To Dream, To Fight, To Win" and that attracted more than 20,000 persons. Several concerts were organized to entertain the participants, and two wellattended fashion shows were sponsored by the Congressional Black Caucus ouses. Representatives of business, government and social organizations took more than 300 booths to showcase their products and services.

PCC Office Of Development And Foundation Reports Successful Year

The Office of Development and the Portland Community College Foundation recently released end-of-year figures for the 1991-92 academic year.

'We wish to thank all the donors from this past year for their support," said Stephen N. Guntili, the director of development and executive secretary of the PCC Foundation.

The PCC Foundation awarded 180 scholarships totaling \$100,970 for the 1991-92 school year. In addition, the Foundation, through its donors, contributed \$184,613 for equipment, instructional materials and staff development to PCC programs. And, 555 donors contributed \$336,701 to the Foundation during the past year.

Success with public competitive grants reached and all-time high; state and federal grants totaling \$2,667,912 were approved for the 1991-92 school

In August, Stephen N. Guntli was named director of development and executive secretary of the PCC Foundation. According to Guntli, future activities include developing a longrange plan with Foundation trustees to expand the level of private funding for PCC programs and scholarships. 

Scott Lively, OCA spokesman, has declared that homosexuality is a mental disorder, linking it with pedophilia, bestiality (sex with animals) and sadomasochism. My own doctor made the comment that "even the Supermarket Tabloids know better than that." He says Lively is clearly and adamantly refuted by the Oregon Medical Association, the Oregon Psychiatric Association and the American Psychiatric Association; all have condemned Measure 9 - Lively, in a recent appearance before the Portland City Club reminded some of that old racist ploy, "Some of my best friends are black." He became misty eyed, telling his listeners, "my friend Sunny just died of Aids, but he became a Christian before he died."

Portland attorney, Charles Hinkle, is a leading spokesman for a large group of Oregonians who believe that passage of measure 9 would be a serious blow to Oregon's economy. Opponents of the antigay amendment to the state constitution point to other states where fight's over social issues have seriously harmed business--especially efforts to attract new industry and/or tourist trade. An official of a Colorada Convention and Visitor's Bureau said that a major social controversy in his state caused a loss of over 150 conventions and a quarter billion dollars (The Rev. Martin Luther King Holiday issue).

If attorney Hinkle has his way Oregonians will vote their pocketbooks as well as a respectable moral persuasion in support of a long tradition of tolerance for diversity. In opposition to Measure 9 he cites, The Associated Oregon Industries, Portland Chamber of Commerce, American Electronics Associations and many other business leaders and organizations. "OCA has embarked on a campaign of distortion and falsehood to mask a vague and broadly written measure that could have widespread effect.

The education establishment is also firmly against Measure 9 with "all its opportunities for vicious mischief from witch hunts for alleged homosexuals to the purging of libraries and a Nazi type control of curriculum". The Portland Observer joins the ranks of all thinking and liberty-loving people who urge that this evil measure be defeated.

Former Key Perot Volunteers In Oregon Endorse Bill Clinton
