Loaned Executives And Volunteer Leaders Guide United Way Campaign

Several members of the Africanamerican community are devoting their time and skills to United Way of the Columbia-Willamette's 1992 campaign to raise \$21.5 million for community wide health and human care programs.

By donating their time to the fund drive, volunteers keep United Way of the Columbia-Willamette's overhead and fund-raising costs at about 15 percent. Eighty-five cents of every dollar contributed goes to support nearly 180 human-service programs located in Clackamas, Multnomah and Washington counties in Oregon, and clark County in Washington.

They work full time raising funds for United Way while employers continue to pay their current

In return for their 12-week commitment, loaned executives gain valuable training and experience in communication and public speaking; account, project and time management; and negotiation and goal-setting skills.

"The combined efforts of our

loaned executives and volunteers will have a profound impact on the future of human services in our community," said Campaign Chairman Roger Breezley, chairman of the board, U.S. Bancorp. "Working together, they'll take us to our goal and help our neighbors of all ages and backgrounds."

Urban League Employment Office Connects Job Seekers With Employers

The Urban League of Portland has been helping Oregonians meet their employment goals since 1945.

The League was originally formed to advocate for African Americans who moved to Portland to build ships during World War II and were denied equal access to jobs and housing after the war. Today the League's Employment Department serves people form many backgrounds and offers services to the unemployed, other job seekers, and employers from throughout the Portland metro area.

Approximately 75% of the League's clients are minorities. The League's outreach efforts target minorities and other protected class job seekers (including women, dislocated or disabled workers, and workers over 40). Services are available to all job

During the last fiscal year the Employment Department placed 160 people in new jobs and helped 1200 people during their job search. All services for job seekers are offered free of

The Employment Office is located at the Urban League Plaza at 10 N. Russell St. in North Portland, at the corner of N. Williams. Service hours are 8:30 am to 5:00 pm Monday through Friday. Job seekers need to call 503/ 280-2600 to set up an appointment to

Services for job seekers include up-to-date job postings and announcements from employers in Oregon, Southern Washington, and Northern California; career counseling; resume writing and interview preparation workshops; on-site interviews with employers; and employment applications from many employers.

"We have more job postings than almost any other public or private employment office in the metro area," says Employment Outreach Coordinator Brenda Sherman-Sanders.

Services available to local employers include prescreening and referring qualified protected class job candidates; assistance with job fairs; assistance with employment-related cultural diversity issues; and assistance with employee

The department is partially funded by local employers, 18 of whom have formed an Employment Partnership with the Urban League. The goal of the Partnership is to help local employers recruit and retain qualified minority job candidates. Employer partners send staff from their human resource departments to work as volunteer job recruiters, career counselors or workshop presenters.

The original partners included First Interstate Bank, Mentor Graphics, NIKE, Standard Insurance and U.S. Bancorp. Since then ARCO, Bank Of America, Boeing Company, Cellular One, City of Gresham, Halton Company, McDonald's Meier & Frank, Nationwide Insurance, Saif Corp., Tektronix, Wacker Siltronic and Zellerbach Paper have joined.

The Employment Office receives

clients through direct referral, networking by staff, and drop-ins. client traffic has been very heavy in recent months. "We do not limit the number of clients we serve," says Ms. Sherman-Sanders. "With the economy in a slowdown we are seeing a big increase in the number of clients.'

Sherman-Sanders says that the most significant barriers to employment for Urban League clients have been transportation, the location of employer offices for interviews, and lack of up-todate information about job openings. The Partnership is working to solve these problems, through on-site interviews and faster transmittal of job opening announcements.

Changes in Oregon's employment picture have created the greatest barrier in providing service, Sherman-Sanders believes. "Our old industries are being replaced by new, higher tech industries which require skills that many displaced workers don't have. And there aren't enough job training programs to help workers acquire the new skills they need."

The Urban League's Employment Department hopes to expand services in the near future. "We hope to offer job training when funding permits," says Sherman-Sanders. "If we could add another service it would be a database listing of local job openings."

Sherman-Sanders encourages job seekers and employers interested in using the department's services to contact the League at orientation.

The Private Industry Council is a private, non-profit organization dedi-

cated to providing training and employment opportunities for economically disadvantaged residents of Multnomah and Washington Counties. A primary goal of the organization is placement of participants in unsubsidized private sector jobs upon the successful completion of training.

Employers being recognized have worked with The Private Industry Council for a number of years providing graduates of TPIC training programs jobs which offer living wages, benefits and opportunities for contin-

ued training and upward mobility. Several of the employers being honored have also participated in the development of industry-specific training programs.

The Council is composed of about 180 occupational health representatives from major employers and labor unions with Kaiser Permanente coverage in Northwest Oregon an Southwest Washington. The Council works with Kaiser

Permanente to improve the effectiveness of the health maintenance organization's services for workers, both at the worksite and during treatment. The Council also conducts education sessions on topics related to occupational health.

Mayor Hails Hatfield Announcement Of \$4.37 Million Federal **Economic Assistance Award for North/Northeast Portland**

"Inner North/Northeast Portland will get a formidable economic boost that will bring positive change to a part of our city that most needs help," said Portland Mayor J.E. Bud Clark, in applauding U.S. Senator Mark O. Hatfield's announcement today of \$4.37 million in federal assistance to fund a comprehensive economic assistance program for the area.

The program, to be administered by the Portland Development Commission (PDC), will uniquely combine business development loans, technical assistance and job training funds targeted to revitalize the economic structure of North/Northeast Portland, build the City's economic base and create jobs for City residents. The program will help implement the North/Northeast Economic Development Alliance's community plan.

"We're deeply indebted to Senator Hatfield for securing a special appropriation for this project," said mayor Clark. "The Senator has worked

untiringly for well over a year to win approval for this award. Congressman Les AuCoin was also diligent and effective in winning support for the appropriation in the House. Senator Hatfield and Congressman AuCoin along with the other members of Oregon's Congressional delegation have made it possible for us to demonstrate through this program that inner city neighborhoods can be revitalized."

The strategies to be implemented under the new program were developed with the assistance and support of the North/Northeast Economic Development Alliance and numerous other members of the community. The \$4.37 million to be disbursed by the Department of Housing and Urban Development will be divided as follows:

Business Development Loan Pro-

Training Development Fund (30%) Technical Assistance Pro-

The business development loan pro-

gram, will provide the capital to encourage job-generating business development and bring new investment into the N/NE area. The program would provide a variety of different loans:

Very short-term "checkbook" or transaction loans of \$500 to \$15,000 to be delivered through community-based organizations with a constituency base of small businesses in the N/NE Enterprise Zone. An example would be a business that needed \$4,000 to meet payroll, with a \$5,500 receivable due in two weeks. The transaction loan would fill the two-week gap.

Short-term loans for a none-year term or less of from \$15,000 to \$50,000 for any business purpose such as purchasing inventory or paying for services to meet business demands.

Long-term loans of \$\$5,000 to \$50,000 for small business needs such as capital equipment needed at expand operand operations and add new em-

Real estate loans of \$10,000 to

\$100,000 for a maximum term of 20 years designed to assist with the purchase and/or renovation of properties in North/Northeast Portland.

The training development fund will provide funds to businesses that engage in substantive training of N.NE Enterprise Zone residents. The goals of this program are to provide job skills to newly-hired Enterprise Zone residents and to add incentives for companies to increase their hiring of Zone residents. Funds will be available for residents hired through the JobNet consortium administered by PDC. Training will be supported only when it helps Zone resident move into careers with long-term job potential.

The technical assistance program will provide aid to North/Northeast business development activities, especially business development loan recipients. Technical assistance will provide a variety of professional services that will facilitate loan origination and support the viability of funded businesses.
