Council Approves Towing Ordinance And Resolution On Implementation

day to approve an ordinance which would empower a police officer to tow any vehicles they find to be operated without insurance. Because the ordinance did not have an emergency clause, it will not become effective for thirty days. The ordinance was amended last week to add a "sunset cause" which provides that the ordinance will expire or "Sunset" after a year of operating if its continuation cannot be justified.

At the same time, City Council unanimously approved a resolution outlining the manner in which they want to see the ordinance implemented. the Resolution:

1. Commits City Council to review the impact of the ordinance after six

2. Commits the City, during the first six months of the ordinance, to pay the

City Council voted unanimously to- towing fee and up to three days storage cost resulting if an officer, acting in good faith, orders the towing of a vehicle which was insured at the time it was towed. Such payment would be limited to one time per vehicle and one time per household or business;

3. Directs the City's Risk Management Division and the Police Bureau to devise an expedient process and the necessary forms to facilitate a person's retrieval of their vehicle without having to pay the towing fee under the circumstances just described;

4. Commits City Council and the Police Bureau to an ongoing public education effort about the ordinance during its first year, with an extensive public education campaign during the thirty days before the ordinance goes into ef-





Highway Traffic Safety Administra- call 366-0123.) **PDC To Consider At November Meeting** Suspension Of Major Redevelopment Project In Airport Way Urban Renewal Area the city, state and the Urban Renewal

The Portland Development Commission (PDC) will consider at its Tuesday, November 10 meeting, a recommendation by staff to suspend activities within the Holman Redevelopment Area, a 95-acre development parcel within the Airport Way Urban Renewal Area, and reallocate resources to other Airport Way projects.

The recommendation is being made due to the recent Oregon Supreme Court ruling on Measure 5 which effectively ended tax increment financing, PDC's main funding source for urban renewal. PDC is the City's agency for urban renewal, housing and economic devel-

Due to the court's interpretation of Measure 5, limited funding remains for the Airport Way Urban Renewal project with no clear prospect for future additional funds. Faced with weighing the Commission's urban renewal funding crisis against the best use of the remaining budget, the new strategy calls for investing funds in public infrastructure projects and development assistance programs. The recommendation does not remove the Holman Redevelopment Area from the Airport Way Urban Renewal Area.

"The commission is extremely reluctant to abandon work in the Holman Redevelopment Area," said PDC Executive Director Patrick LaCrosse. "We've invested substantial staff time and public money on this important project. The Commission has worked extensively to shape the vision for the Airport Way Area and help it reach its full potential. However, we must make tough decisions as a result of Measure 5."The Holman Redevelopment Area is located near N. E. 112th and Airport Way. It has been identified as having the potential to develop into a high density, high quality employment center. Its location makes it an natural "gateway" to Area. It has been estimated that the Holman Area, when fully redeveloped, could support up to 2,800 new jobs.

PDC has committed remaining resources to continue infrastructure improvements to capitalize on the \$30 million in public investment already made in Airport Way. In addition, staff will continue to offer technical assistance in transportation and environmental issues as well as plans for development loans to property owners and developers in Holman and the rest of the Urban Renewal Area.

The Airport Way Urban Renewal Area was adopted by City Council in 1986. The renewal area is potentially the most important future employment center in the region. If the City finds a way to continue funding urban renewal, an estimated 20,000 jobs for area residents are expected in the Airport Way area in the next 20 years.
