The Port Of Portland Request For Proposal Advertising Concession

Sealed proposals for the Advertising Concession will be received at the office of the Manager, Contracts and Procurement, of the Port of Portland, 700 N.E. Multnomah Street, 15th Floor, Portland, Oregon, (mailing address: P.O. Box 3529, Portland, Oregon 97208) until 5:00 p.m. on April 5, 1993.

A mandatory pre-proposal conference will be held Tuesday, February 16, 1993 from 1:00 to 4:00 p.m. in the PDX Conference Center at Portland International Airport's main terminal building.

Scope of Work

The Port of Portland is requesting Proposals for the right to the display advertising concession for the Portland International Airport for a period of five years. The concessionaire will design and install, at their expense, all new advertising displays in the airport terminal building. The concessionaire will then be responsible for selling advertising or those displays and maintaining them on a daily basis.

The Port is in the process of expanding the existing airport terminal building and adjacent concourses. During this expansion, existing advertising display units may have to be relocated temporarily or permanently at Proposer expense. Additional displays provided during the contract term are to be added at no cost to the Port.

Proposals are to take into account these costs as well as increases in service resulting from this expansion. Current expansion plans will be discussed at the pre-proposal conference.

Minimum Requirements

Proposers must have been in the advertising business a minimum of three years during which time they must have serviced a site generating at least \$200,000 in annual gross advertising receipts. In addition, Proposers must have an established sales organization with the proven ability to sell to and service local, regional, national, and international accounts.

Proposals must comply with the proposal instructions contained in the RFP and include all requested information in the form specified.

Request for Proposal packets may be examined at the above Port offices. Copies may be obtained by prospective proposers at no cost.

Proposals may be rejected if not in compliance with procedures and requirements. Any or all proposals may be rejected if in the public interest to do so.
