McNary Field Airport Sign And Runway Lighting Improvements

The City of Salem will receive sealed bids at the office of the City recorder, Room 205, City Hall, Salem, Oregon 97310, until, but not after 11:00 a.m., May 12, 1993 at which time said bids will be publicly opened and read in the City Council Chambers, Room 240, City Hall for the project specified herein.

PRIME CONTRACTORS interested in bidding on this project may receive one copy of the specifications and other bid documents at the office of the Purchasing Supervisor, 555 Liberty Street, SE/Room 330, Salem, Oregon 97310-3503, telephone (503)588-6136.

WORK DESCRIPTION: This project includes: furnishing and installing approximately 66 new airport signs; removal of existing signs; furnishing and installing constant current regulator and related wiring and duct for a new sign circuit; the relocation of selected high intensity runway edge lights; furnishing and installing approximately seven new semi-flush runway edge lights; and, all related work to complete the project.

Bids must be submitted on the proposal forms furnished to the bidders. Proposals shall be submitted in a sealed envelope plainly marked "BID ON MCNARY FIELD, AIRPORT SIGN AND RUNWAY LIGHTING IMPROVEMENTS, BID # 4212" and show the name and business address of the bidder.

Any objections to or comments upon the Bid specifications must be submitted in writing to the office of the Purchasing Supervisor, City Hall, Room 330, 555 Liberty Street S.E., Salem, Oregon 97301. They must be received no later than ten (10) working days before the bid closing date.

A surety bond, cashier's check, or certified check of the bidder in the amount of ten percent (10%) of the bid must be attached to each proposal as bid security. Unsuccessful bidders will have their security refunded to them when the contract has been awarded.

Bid, EXCEEDING \$2,000, will be received or considered by the City of Salem or any of its officers unless the bid contains a statement by the bidder (by signing his proposal) that the provisions of the Davis-Bacon Act (40 U.S.C. 276a) shall be

included in his contract. Every contractor or subcontractor is required to post the applicable prevailing wage rates in a conspicuous and accessible place in or about the work-site for the duration of the job. Contractors and subcontractors who intentionally fail to post the PWR can be made ineligible to receive any public works contract for up to three years.

Federal funds are being used on this project. In all instances where there is a conflict between the local and federal provisions, federal provisions prevail, which provisions include but are not limited to the Department of Transportation Disadvantaged Business Enterprises programs and federal wage rates.

- The proposed contract is under and subject to Executive Order 11246 of September 24, 1965, and to the Equal Employment Opportunity (EEO) and Federal Labor Provisions.
 - All labor on the project shall be paid no less than the minimum wage rates established by the U.S. Secretary of Labor. Federal wage rates are contained in the bid documents.
 - The EEO requirements, labor provisions, and wage rates are included in the specifications and bid documents and are available for inspection at the City of Salem Purchasing Division, Department of General Services, Room 330, 555 Liberty Street SE, Salem, Oregon 97301.
- Each bidder must complete, sign, and furnish with his bid a "Certification of Nonsegregated Facilities" and a statement entitled "Bidders Statement of Previous Contracts Subject to EEO Clause", as contained in the bid proposal.
- A contractor having 50 or more employees and who may be awarded a subcontract of \$50,000 or more will be required to maintain an affirmative action program, the standards for which are contained in the specifications.
 - Where a bid of the apparent low responsible bidder is in the amount of \$1 million or more, the bidder and his known first-tier subcontracts which will be awarded subcontracts of \$1 million or more will be subject to full, on-site, pre-award equal opportunity compliance reviews before the award of the contract for the purpose of determining whether the bidder and his subcontractors are able to comply with the provisions of the equal opportunity clause.
 - To be eligible for award, each bidder must comply with the affirmative action requirements which are contained in the specifications.

8. Disadvantaged business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin in consideration for an award of any contract entered into pursuant to his advertisement.

9. Women will be afforded equal opportunity in all areas of employment. However, the employment of women shall not diminish the standards or requirements for the employment of minorities.

RECIPROCAL PREFERENCE LAW: In compliance with ORS 279.029, bidders must state on their proposal whether they are a resident or non-resident bidder.

The City of Salem reserves the right to reject any or all bids, to waive formalities and of postponing the award of the contract for thirty (30) days. Prices quoted shall be firm for a period of 30 days after the closing date.

The attention of bidders is directed to the provisions of Chapter 97, Salem Revised Code, concerning unlawful employment practices. Violation of such provisions shall be grounds for immediate termination of this contract without recourse by the contractor.

Vendors shall use recyclable products to the maximum extent economically feasible in the performance of the contract work set forth in this document.

No bid for a construction contract shall be received or considered by the public contacting agency unless the bidder is registered with the Construction Contractors Board or licensed by the State Landscape Contractors Board as required by ORS 671.530.

The City of Salem is an Equal Employment Opportunity/Affirmative Action Employer.
