Disadvantaged Business Enterprise (DBE) Program:

Bidders are required to show that small subcontractors, suppliers, or manufacturers which have been certified by the Oregon Executive Department as disadvantaged, minority, or women business enterprises (collectively "Disadvantaged Business Enterprises" or "DBEs") will participate in not less than 13 percent of the total dollar amount bid.

Description of Work:

Construct approximately 11,700 square yards of asphalt concrete taxiways to serve three proposed "T" hangars. Work includes associated subgrade sterilization, taxiway painting, storm sewers, seeding, and installation of taxiway edge reflectors.

Asphalt Concrete Paving-Highways, roads, streets, and Airports

Prequalification applications must be submitted not later than 5 business days prior to the bid opening date.
