- 2. Schedule B-Grade School Pump Station, Force Main, Outfall and Gravity Sewer: The works includes demolition of the existing pump building, standby power system, valve vauit and construction of pumps into the existing wet well. The work also includes installation of 2050 feet of 15-inch outfall pipe, 834 feet of 6-inch waterline, 2706 feet of 10-inch force main and 396 feet of 12- inch gravity sewer. The work also includes modifications to five existing lift stations to provide portable standby power and telemetry.
