## Housing Authority Of Portland Request For Qualifications Underwriting Services

The Housing Authority of Portland (HAP) wishes to establish a listing of qualified underwriters for its Multifamily Bond Program. The program will utilize two basic types of tax-exempt revenue bonds: 1) issues of HAP-owned properties backed solely by project revenues and HAP's covenant of general revenues not already pledged to a specific purpose; and 2) rated or ratable issues with either credit enhancement or mortgage insurance for which usually serve as a conduit issuer.

HAP expects to undertake no more than two projects in each of these categories within the next year, issues are likely to range between \$5-million and \$10-million each. The agency wishes to qualify underwriters for each category in advance in order to maximize cooperation and minimize delay as a project is being analyzed and prepared for under writing.

Once the list is established, HAP reserves the right to negotiate with any qualifying institution without additional process or notification. The list will remain in effect for two years.
