When the two black men went into the Albina Head Start Program's office and committed this crime in broad daylight, it pointed out how deep a problem alienation is in the black community. And they used handguns to commit this crime. Alienation has caused Blacks to lose control of their community.

The black community can no longer ask others to solve alone the crime in their community while they blame them for causing the problems. The soul of this community is at stake because of this hideous and heinous killing. No one should be sheltering these individuals. Now is the time for this black community to stand up.

The Portland black community must be an active part of solving this crime. Door-to-door blitzes should be done to ferret out any possibility that someone is harboring these killers within the black community. In addition to any reward, members of the black community must take back their community and report all forms of violence.

Law enforcement agencies can not solve this crime by themselves. The expectation from law enforcement units should not be minimized because this crime occurred within the black community. This crime should not be viewed as only a Black on Black crime. It is reprehensible to think of it in that way. The total community suffers.

A number of meetings have been called to deal with the emotional aspect of this crime and to lay ground work for other group actions. All citizens want to do something. But, the black community must not allow these killers to find shelter with its community.

### **U Of P Sponsors Non-Violence Leader**

Rev. Emmanuel Charles McCarthy will be the featured speaker for a three-day conference titled "The Spirituality of Christian Non-violence" Sept. 17-19 at the Franciscan Renewal Center in Southwest Portland. More than 50 lay leaders and clergy from several states will participate.

McCarthy helped create PAX CHRISTI, U.S.A., an international Catholic peace organization in the early 1970s. He later helped co-found the Center for Christian Non-Violence at the University of Notre Dame. This spring McCathy participated in the commemoration in Memphis, Tenn., in honor of the 25th anniversary of the assassination of Martin Luther King, Jr.

During his career McCarthy has worked with such world figures as Nobel peace laureate Mairead Corrigan McGuire, a founder of the Northern Ireland Peace Movement.

Nationally known theologian McGuire has praised McCarthy's retreats as a "remarkable contribution to furthering the understanding of Christian nonviolence -- so urgent a need today."

The University of Portland Campus Ministry and Peace Studies Program is co-sponsoring the retreat with the Franciscan Renewal Center and Catholic Peace Ministry in Oregon. The cost of the three-day retreat is \$80 for overnight guests and \$40 for commuters. Financial aid is available.
