Rosie Perez Doesn't Let Racism Get In Her Way

"I said I wanted to play Jessica Lange roles, but I didn't mean I wanted to play white roles," declared actress Rosie Perez, who has learned how to handle racism in her career and per-

"I would love to play a Hispanic," Perez added in an interview to be published this Sunday in PARADE magazine. "I dream of starring with Andy Garica...Unfortunately, all the quality work caters to white actors. I just want a chance at good parts."

To date, the Puerto Rican actress has won two roles initially intended for white actresses--the girlfriend in "White Men Can't Jump" and a plane crash survivor in the forthcoming "Fearless."

Perez said she learned to deal with racism while still in high school when she tried out for the cheerleading squad. "It was all white, and my friends told me I wouldn't get it," she recalled, "but I thought to myself, 'This is what I want, and I'm not going to be scared.' I remembered what an old black man had told me. He owned a big house and two barbershops, and my sister asked him how he got all that. He said, 'I don't let racism get in I think back to those words, and they get me moving."

"Sure, being the recipient of racism makes me angry and bitter," Perez added, "but it's really important to overcome the bitterness. If you don't, you can begin to

Mutlnomah County Chair Beverly Stein announced a major new initiative to expand and develop family support centers in neighborhoods throughout Multnomah County.

Funds will be made available for this initiative by reorganizing the Multnomah Department of Social Services and vacating the positions of the Department Director and his staff. In addition, two divisions will be merged, reducing the number of divisioins from four to three. All of the divisioins will report directly to the Chair.

Stein poposed that the \$300,000 projected to be saved through the reorganization be used to fund Parent Child Centers in each of the six County service districts.

Why, sine 1980, has the federal their "education" in U.S. prisons than in college? Why do we see four times as many Blacks languishing in U.S. jails than in South African prisons? A major culprit, Mandatory Sentencing

Mandatory sentencing laws prohibit a judge from considering any circumstances other than the type of drug and its weight, or the presence of a firearm, when imposing a sentence. For example, the Omnibus Anti-Drug Abuse Act of 1988 requires a mandatory minimum sentence of five years for a first time offender's possession of more than five grams of crack cocaine--the equivalent of approximately 5 packets of artificial sweetener. For possession of 100 times the amount of powder cocaine, the minimum sentence is probation. This discrepancy is sentencing is intolerable and constitutionally suspect. > A virtual Pandora's box of evils has been unleashed onto society. They have manifest themselves in the demolition of judicial discretion. Mitigating factors are often dismissed and judges are forced to impose draconian sentences. This forces a blind adherence to sentencing which results in low-level participants receiving moire time than top-level "kingpins". There is racial disparity whereby Blacks and Hispanics are charged with and receive sentences at or above the mandatory minimum more often than Whites arrested on the same charges. Because of this, prisons become overcrowded, which results in violent criminals, many of whom are not subject o mandatory penalties, being released early.

Civil liberties have been eroded ended. USA Today recently ran a by gutting safe-guards against unreasonable searches and seizures; the weakening of the presumption of innocence through preventative detenrate of Whites for essentially the tion; the stepping up of dispropor-

tionate punishment through unwarranted civil forfeiture of assets; expansion of the use of entrapment, abusive treatment of public housing tenants; police brutality; and growing federalization of law enforcement.

Last November we voted for an urban stimulus package which promised hope for our cities and our people and a solution to an acute problem. Instead of creating jobs and ways to reconstruct lives, the administration has created new criteria to execute people. Instead of instilling new life and hope into the neighborhoods of Detroit, Los Angeles, Chicago and Washington, the administration plans to install 100,000 more police officers onto our streets.

The use of drugs is a societal problem. A problem we need to fight by waging "war" through education, prevention, counseling, treatment on demand and cure, as well as punishment. Even when there is punishment, there should not be double time for the same crime! So far, the cumulative effect of the policies pursued in the name of a "war on drugs" has, in fact, turned out to be a war against the Black, the Brown and the poor.
