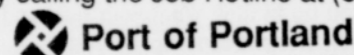

Sealed proposals for the City of Cannon Beach, Water Treatment Plant, addressed to Jerry Minor, P.E., City Engineer, 7080 S.W. Fir Loop, Portland, Oregon 97110, will be received at the offices of KCM, Inc. at the same address until 4:00 p.m. on March 30, 1994 and then will be publicly opened and read. Principal items of work shall generally consist of the following: Construct a Water Treatment Plant of 1 million gallon per day (mgd) capacity including intake and filtered water pump stations, slow sand filters, sitework and site piping, and associated work.
