- 1. A complete reconstruction of the Coliseum that lowers the event floor 35' to provide a new seating bowl-geometry within the existing building envelope. Construction will retain the existing concrete edge beam, glass curtain wall and steel roof trusses.
- 2. An expanded service yard to the South.
