## **NECA/IBEW Electrical Contractor Helps International Research Team**

In a project scheduled to be completed next month, McCoy Electric Company, a member of the National Electrical Contractors Association (NECA), Oregon-Columbia Chapter, and the International Brotherhood of Electrical Workers (IBEW) Local 48, is replacing the old, troublesome electrical system in the Shriners Hospital laboratories with three separate new systems which will ensure that the labs will no longer lose critical data due to what is sometimes known as "dirty power."

Dirty power is electrical power that spikes, surges, and doesn't flow smoothly -- and it can spell disaster for today's highly sensitive electronic equipment, such as the laboratory research equipment used at the Shriners Hospital for Crippled Chil-

Years of research can be destroyed in an instant if electrical power is interrupted. In fact, that's what had been happening before McCoy replaced the system. The labs had not only lost experiments, they were also regularly having to replace the hard drives in their computers due to surges -- an expensive proposition in both dollars and data lost.

In order to prevent such losses in the future, the Shriners Hospital called on McCoy Electric to upgrade the quality of power coming into the Lab.

According to McCoy Project Superintendent Jim Hall, the company designed and installed three separate systems in five different labs so that the right equipment can now be connected to the right type of electrical system. "With the new systems, if the electricity coming into the hospital goes down, the critical lab equipment will never know it," said Hall.

The Normal Power System was installed for non-critical equipment; equipment that is used occasionally and usually not for extended periods of time. The Emergency System is reserved for equipment that can tolerate a two or three second interruption until the emergency generators kick

plex, we don't need any more problems. The new electrical work makes it much easier for us to concentrate on the work we want to do rather than worrying about the equipment."

In addition to the design and installation of the electrical work, the union electrical contractor provides on-call back-up personnel who are available to take care of any problems that might arise. McCoy has also made other contributions to the ongoing research at the Shriners Hospital for Crippled Children.

## Filing Extensions Offered To Those Who Can't Pay

April 15 federal income tax filing ment penalty of 1/2 of one percent of deadline, need IRS Form 4868, "Application for Automatic Extension of Time to File U.S. Individual Income Tax return." The IRS now accepts an application for an automatic four month extension of time to file, even if the taxpayer can't pay the total tax

filed an extension and didn't pay the tax with the extension, IRS would consider the request invalid and assess the failure-to-file penalty on the delinquent return. The failure-to-file penalty is 5 percent per month on the balance due on the return, not to exceed 25 percent.

To get an automatic four month extension of time to file, Oregonians should file Form 4868, and properly estimate their tax liability.

Even with the extension, there are interest charges on any taxes paid after April 15. If payments made by April 15, including amounts paid with Form 4868, are less than 90 percent of

Oregonians who cannot meet the the total tax, there is also a late payyour unpaid taxes for each month or part of a month that the tax is not paid. To keep these charges as low as possible, the IRS advises taxpayers to pay as they can as soon as they can. Taxpayers may even make payments before they actually file their returns.

Any payments made before fil-Prior to last year, if a taxpayer ing should include information to credit the money properly: social security number (SSN), the tax year and the form number. Joint filers should use the primary SSN -- that is, the number that will appear first on the return.

> Taxpayers who still cannot pay the taxes owed by the August 15 extended due date should file their returns and attach Form 9465, "Installment Agreement Request." This form allows taxpayers to request a monthly payment plan and specify the amounts they are able to pay each month. The late payment penalty and interest continues to be charged on any unpaid tax.

Both Forms 4868 and 9465 are available in local IRS offices. Also, some libraries have reproducible copies of Form 4868. If you do not have access to a copy of Form 4868, you can request an automatic four month extension for filing your 1993 personal income tax return by mailing a letter by April 15, specifying the tax year, type of return involved, your social security number, estimated tax, and any balance due. If a joint return, both spouses must sign. The letter must be signed using the following statement:

"Under penalties of perjury, I declare that I have examined this substitute from, including accompanying schedules and statements, and to the best of my knowledge and belief, it is true, correct, and com-

A similar lawsuite involving an opportunity to make a real differ- the same company was filed by the Washington Attorney General.

Named in the Oregon complaint is Capitol Marketing, Inc. and its president, Kenneth Ecklund of Seattle. The complaint alleges violations of Oregon's Unlawful Trade Practices

Washington Attorney General Christine Gregoire filed a similar, separate lawsuit against Capitol Marketing and Ecklund. Gregoire's office also sued Certified Subscription Service, Inc., Consumer Subscription Center, and Seattle residents Carmen Smith and Lorna Ecklund. Kenneth Ecklund is believed to be involved in all three operations.

Capitol Marketing is alleged to have renewed subscriptions and billed consumers without authorization. The company also is alleged to have accepted money for subscriptions but did not send it to the magazine pub-

Consequently, consumers never received magazines they subscribed to through Capitol.

Capitol gave refunds to some consumers, but only after being contacted by the Oregon Department of Justice. The company was asked to enter into an Assurance of Voluntary compliance earlier this month, but never responded to the request.

Oregon's complaint seeks to permanently prohibit the defendants from operating in Oregon, civil penalties of \$25,000 per law violation, restitution to all Oregon consumers and attorney fees and investigative costs.
