Bidders are required to show that small subcontractors, suppliers, or manufacturers which have been certified by the Oregon Executive Department as disadvantaged, minority, or women business enterprises (collectively "Disadvantaged Business Enterprises" or "DBEs") will participate in not less than 5 percent of the total dollar amount bid.

Description of Work:

Installation and connection of Port-furnished airfield lighting regulators, monitoring equipment, and other airfield lighting control system components.

A prebid conference will be held on Thursday, July 14, 1994, at 10 a.m. in the Columbia room of the conference center at the Portland International Airport Terminal building, to discuss all phases of the work. The airport conference center is located at the top of the stairs which are near the clock tower in the concession lobby.

This is a federal contract, and all labor shall be paid no less than the minimum wage rates established by the U.S. Secretary of Labor, as included in the contract documents.


