## **Oregon Arena Minority Contracting:** A Case Of The "Tale Blazers"

The people at the Oregon Arena project ought to write a book on how to deceive the public.

Never in my life have I seen such a masterful job of shoving out the "B.S." on minority contracting and job hiring, particularly as it relates to African-Americans. As the Arena project begins to take real form and rise towards the sky, the massive structure of concrete and steel becomes a monument to lies and deception. While the Oregonian newspaper and other major media sources have not been perpetuated the lies of late, a recent series of pronouncements in community newspapers have helped spin this great yarn.

It's pretty incredible. From day one, Mayor Katz, Rep. Ron Wyden and most other public officials lauded the accomplishments of the project before it even broke ground. And you've got to hand it to them, from community-based organizations.

Another excellent strategy was to employ a local negro "front man," who already had plenty of experience selling over-rated and overpriced cars. And while we are not talking about automotive retail sales, we are talking about making the public believe they are getting something that they are really not.

Speaking of negroes, a few weeks ago Drake/Turner brought to town their national company negro, Hilton Smith. While it is obvious that Smith is getting paid by Turner to keep the minority contracting thing in line, they also tried to use his association with the National Association of Minority Contractors to rebuff the efforts of the Portland chapter, the National Association of Minority Contractors of Oregon (NAMCO) to expose the real participation of African-American contractors and workers on the project.

There were particular concerns about the utilization of African-Americans who are believed to be unemployed at around 15%. Similarly, African-Americans contractors are historically absent or used primarily as "fronts" on such major construction projects.

As it turns out, until just recently, the City had no real mechanism for monitoring compliance on this or any other project. The City had to take the Arena project's word for its accomplishments. And since the City had already endorsed the project, I assume there was a lessthan-real interest in uncovering defi-

Nevertheless, the City is making progress and moving ahead to complete a disparity study to assess discrimination in the contracting industry. Crucial to that is the fact that the city attorney has also hired a fulltime compliance counsel. All this is good, but most assuredly is too late to reign in the Arena project. Consequently the Arena project will undoubtedly feel free to make up fanciful tales about their accomplishments in the absence of any real scrutiny. And in all likelihood when the project is completed, the story will be the same. No matter how many games the 15 or so Black athletes stain their uniforms to win in the new arena, as far as this project is concerned, once again Black people in this city will be the big losers, courtesy of the "Tale Blazers".

## Oregonians Warned To Beware Of Insurance Scam

The Oregon Insurance Commissioner and New York Life Insurance Company are warning Oregonians of an insurance scam targeting primarily elderly residents.

In several instances a con artist has contacted the close relatives of recently deceased people and encouraged them to send money that will entitle them to a death benefit payment from New York Life. The man is not affili-

ated with New York Life, and the company has made it clear that the payment does not entitle the consumer to any death ben-

"This scam targets consumers when they may be most vulnerable -- while they're grieving for a loved one," said Kerry Barnett, Oregon Insurance Commissioner. "Insurance companies usually communicate directly with their customers in writing or through licensed agents. We are warning people to treat any offer like this with great suspicion.'

The commissioner is urging Oregonians to make certain they are dealing with a licensed insurance agent before giving that person any money or a credit card number. Although the individual has used New York Life in the past, consumers should watch for similar ruses using other insurance companies, as well. 
