Arbitration is the voluntary submission of a dispute to an independent neutral person or persons for a final and binding decision. The Oregon Business Arbitration Rules were developed specifically to meet the overwhelming demand by Oregon disputants and their attorneys for an inexpensive and efficient forum to resolve business disputes. The program allows for lower filing fees, and expedited arbitrator selection process, rules of discovery and the freedom to communicate directly with the arbitrator for the fastest possible

"The AAA's new rules have been introduced alongside the Association's more traditional procedures, which still offered for all clients that continue to prefer traditional benefits and safeguards of the AAA's Commercial Arbitration procedures," said Mr. Mead.

Under the new rules, disputants will select an arbitrator, or a panel of three arbitrators, from the AAA Oregon panel or the AAA's national panel of arbitrators, both consisting of recognized and respected attorneys, retired judges and business pro-

#### Volunteer Internship For **Mediation And Facilitation**

he Neighborhood Mediation Center (NMC) is looking for volunteers who are trained and/or experienced in mediation and facilitation.

NMC will provide additional training to the selected volunteers and, in return, the Mediation Center is asking for a year-long, three-hour per week volunteer commitment.

The training and year-long internship will provide opportunities for the volunteers to work in the entire continuum of the mediation process including extensive case-development, observation of mediations and co-mediating neighbor-to-neighbor disputes. Neighbor-to-neighbor disputes include problems of noise, e.g., barking dogs and loud stereos; parking, e.g., shared driveways and limited space on streets; disputed boundaries; vandalism; interpersonal disputes; property maintenance disagreements and harassment. There will also be opportunities to co-mediate multi-party disputes.

Opportunities will include fa-

cilitating various kinds of neighborhood meetings as well as meetings sponsored by other city agencies. Additional opportunities for specializing in issues relating to low-income and special needs housing will be available in coordination of the Bureau of Housing and Community Development.

This training will be provided at a cost of \$20.00 per person.
