Sealed proposals for paving and sidewalk improvements to the Prineville Senior Center will be received at City Hall, 400 East Third Street, Prineville, Oregon 97754 until 3:00 p.m., local time, Thursday, March 9, 1995, at which time the bids will be publicly opened and read. Bids shall be titled: Bid: Paving and Sidewalk Improvements to Prineville Senior Center.

The work contemplated consists of:

 Surfacing the parking area by adding base aggregate and asphalt concrete pavement.

Replacing concrete sidewalks around the majority of one city block, including wheelchair ramps, driveway drops,

and curbs.

Work under this contract will be funded in part with grant funds from the Oregon Community Development Block Grant Program (Grant No. C94021). The total project budget (for construction) is approximately \$52,600.
