Affirmative Action An Endangered Species?

If so, we are yet to hear those cries of sympathetic concern or calls for immediate implementation of "life-support" as was the case with the nation's old forests, Stream Salmon and Spotted Owls.

Perhaps it is early on yet, but we have not seen in either high places or in groundswells of public opinion an enthusiastic defense of a valuable socio-economic tool that has at least made 'some' inroads into the country's racist and sexist hiring practices.

What we do have early on is a flurry of media interrogations of government, state and industry officials that has produced a 'Guiness Book of Records' number of "off-therecord" and "don't quote me" interviews. From the President and White House to State Houses and Human Resource Managers, we have people whose commitments are wavering, bending and bowing in the winds of the right Wing attack on Affirmative Action like reeds in a shallow seavacillation is in style.

And as we identify the most shrill and active congressional opponents of Equal Opportunity laws, the Right Wing and Conservative Republicans who told the American public that "Term Limits" was about the most important of the Ten Commandments of their contract with America, we note that "Term Limits" is the `only' element of the contract they have reneged on. And what happened is that many now-frightened little hypocrites (including some Democrats) got the feedback from home that they were gong to be called on the carpet for their treachery. In the age-old manner of politicians who wish to remain feeding at the public trough, they embraced the hottest card in America's political deck, "RACE'.

"Willie Horton" won a presidential election for George Bush didn't he, they reasoned; why not jump on this Affirmative Action thing to divert the voters from a close inspection of the 'smoke and mirrors' of our attacks on social programs. "The media is giving all possible coverage (impetus) to manipulation of white resentment to this 'reverse discrimination'", they further reason (much overstated by willing accomplices). "And look at the big erack in the wall in the NAACP, now is a good time for rolling back this `racial diversity' thing!"

The more perceptive among us have long anticipated a counter attack on a system that was designed to end the centuries-old patterns of racial dominance and 'offered' relief and hope to tens a of millions of America's citizens who had long since given up hope of having an equal opportunity in the land of their birth (not that his goal has been achieved yet).

If anyone should hold "resentment," it should be the African American who for over a century has watched the newest European Immigrant enjoy a superior opportunity, in the job mart, in the finance and banking structures or in leasing, housing and contracting -- all of which the establishment unequivocally states to be an absolute prerequisite for the enjoyment of life, liberty and the pursuit of happiness.

Price, President of the National Urban League puts the crisis in these terms. "The black beneficiaries of Affirmative Action are being positioned as the wedge issue of the 1996 election campaign."

This Is One Time When Black Contractors Should Agree With A White Conservative

ew African-Americans are aware that in the next few months the Supreme Court will decide a court challenge that could possibly do away with all f e d e r a I I y - m a n d a t e d, disadvantage business set-aside programs on federallyfunded projects.

The case, known as "Adaran vs. Pena," involves Adaran Construction, a white-owned Colorado firm, losing a bid to a competitor because of a minority preference program. Upset because the company's low bid was denied in favor of the other company, which got points for using a minority subcontractor, Adaran filed suit against the Federal Highway Administration.

This case has broad implications for African-Americans far beyond the seemingly narrow focus of disputing contractors. For example, it is likely to be the quintessential test case for new attacks against all races based preferential programs. In fact, it could be the biggest nail in the coffin, adding to other efforts to kill all affirmative action as a matter of public policy.

I suppose there is a more tactful way of saying it, but this is all about Black people being continually kicked in the butt. Some will say that I always try to make it a Black thing. But this time, it ain't just this angry Black antagonist with a knack for blaming white folks. This same message also comes from none other than arch conservative and nationally-known columnist James Kilpatrick. In a recent article in the Oregonian, he tells the story about how these set-a-side programs were originally designed and implemented to address a specific condition of discrimination against Blacks in the heyday of the Civil Rights movement. And, during this period, discrimination and racism against African-Americans was well established and extensively documented.

But even before this case surfaced, it's clear that everybody and their brothers are benefiting form the current programs except African-Americans. For example, during the 93/94 construction season, African-Americans did not receive one major contract from the multi-million dollars spent on federal aid projects in Oregon. Moreover, the pattern is essentially the same nationally, regardless of the prominence of Blacks in urban population centers.

Conversely, as a result of legislative change in 1986 involving a combining of mandated goals, white females have become the main beneficiaries of disadvantaged programs. But even before the advent of white female dominance, Blacks as an ethnic group were not benefiting in relation to their acknowledged economic deprivation and historical discrimination. Consequently, the case that Kilpatrick convincingly makes, and with which we must agree, is that these federally-mandated programs have been compromised.

Kilpatrick knows that from the beginning these programs were designed to fail. Affirmative action represented meager, half-heart attempts at fairness by white liberals. On the one hand, while conservative whites were initially tolerant, they worked tenaciously behind the scenes to sabotage the programs.

Therefore, as far as African-Americans contractors are concerned, the notion of affirmative action has proven in many cases to be more harmful than helpful. But contrary to the opinion of the white conservatives, they are harmful for very different reasons. Nevertheless, there's no question that these programs must be corrected and re-directed, based on legitimate need, or scraped altogether.


