**Description of Work:**

Excavate approximately 21,000 square yards of existing asphalt concrete pavement. Pavement thickness ranges from 2 inches to 4 inches. Augment, grade, and trim the underlying aggregate base to restore proper drainage patterns. Construct new asphalt concrete pavement over the restored base.

The Port of Portland is committed to providing equal opportunities to State of Oregon certified Disadvantaged Business Enterprises (DBEs) in contracting activities. The DBE participation target for this project is 25 percent. The Port encourage bidders to exercise good faith efforts, as defined in ORS 200-045(3), to obtain DBE subcontractor participation on this contract. 


