**Drug, Vice Seize Meth**

Officers from the Drug and Vice Division seized almost five pounds of suspected methamphetamine from two men the evening of June 21. The street value of the meth is estimated at about \$200,000.

The two suspects were charged with Possession and Distribution of Methamphetamine and lodged at the Justice Center Jail with bail of \$500,000 each.

The arrests were part of an operation where narcotics Officers Chris Uehara and Eric Hendricks posed as drug buyers.

The suspects offered to sell them methamphetamine, and met the undercover officers at a Southeast Portland motel, where they were taken into custody with the drugs.

Arrested were Pedro Montano Aguilar, DOB 03-25-72 and Jorge Vargas Valencia, DOB 01-24-74.
