## Honoring Widows Of Civil Rights Leaders

Three prominent widows of civil rights leaders--Mrs. Coretta Scott King, Mrs. Myrlie Evers-Williams and Dr. Betty Shabazz will be honored at the 11th Annual Brunch of the National Political Congress of Black Women (NPCBW) on Sunday, September 24, 1995, as a finale to the annual Congressional Black Caucus Legislative Week.

More than 1,500 African American women and men from throughout the country are expected to attend the highly popular brunch, scheduled to begin at 10:00 a.m. at the Hyatt Regency Hotel on Capitol Hill in Washington.

Dr. C. DeLores Tucker, National Chair of NPCBW said, "The lives and accomplishments of these three women are remarkable in what they have had to overcome--personal tragedy, grief, the awesome responsibilities of raising their children, having

the courage and commitment to continue in the struggle for equal rights and economic progress. These three women demonstrate the courage, faith, determination, talent and resourcefulness of Black women everywhere. For our young people who are searching for role models, Mrs. King, Mrs. Evers-Williams and Dr. Shabazz (the widow of Malcolm X) offer guidance and inspiration."

Mrs. King is the founder of the Atlanta based King Center for Non-violent Social Change, and led the successful effort for the passage of federal legislation making Dr. King's birthday a national holiday.

Dr. Betty Shabazz is the Director of Institutional Advancement and Public Relations/Cultural Attache' for the Medgar Evers College of the City University of New York, and a nationally recognized expert on the sociological and economic conditions

of minorities.

Myrlie Evers-Williams former corporate and government executive, now heads the National Association for the Advancement of Colored People (NAACP).

The non-partisan NPCBW was founded in 1984 to encourage the political aspirations of African American women. The focus has been on education and training millions of African American young women so that they might be prepared for leadership positions in the 21st Century. NPCBW also leads a national educational campaign against "gangsta rap" and misogynistic song lyrics directed toward African American youth.
