Multnomah County's Department of Juvenile Justice Services (DJJS) is currently seeking qualified candidates to provide the following services:

- Residential drug and alcohol services for youth 15-17 years of age, that are culturally centered and appropriate for youth from different racial and ethnic backgrounds, currently involved with DJJS Juvenile Probation Services and Family Service Centers;
- Outpatient drug and alcohol services for youth 15-17 years
 of age, that are culturally centered and appropriate for
 youth from different racial and ethic backgrounds, currently involved with DJJS Juvenile Probation Services and
 Family Service Centers;
- Use of "No Decline" policy in the acceptance of youth referred for drug and alcohol services who are at risk of continued involvement with the Juvenile Justice System. Youth will be referred from DJJS Probation Units and Family Service Centers;
