Tyson Is Champ Again

Mike Tyson completed his yearlong journey from convict to champion Saturday with a third-round knockout of Frank Bruno of Britain to win the World Boxing Council heavyweight title at Las Vegas.

Tyson's victory comes almost one year after his release from anIndiana prison last March 25th after serving a 3 1/2 years for a rape conviction. Tyson regains a portion of the heavyweight title he lost in February 1990, on a 10th round knockout by Buster Douglas in Tokyo.

Tyson set the tone for Saturday's fight in the opening 10 seconds when he landed two hard right hands to Bruno's chin. Tyson continued to land repeatedly with his right hand and only constant holding tactics by Bruno kept Tyson from ending it in the opening round. Tyson staggered Bruno throughout the opening round and opened an inch-long gash in his left eyebrow just before the bell.

The second round was a virtual replay as Tyson hammered away time and again with his right hand and Bruno hung on for dear life. Referee Mills Lane took a point away from Bruno for his holding tactics in the

second round, but it did not stop the British champion. He continued holding on for dear life through the second round and early into the third. Early in the third round, Tyson rocked Bruno with a savage left hook to the head and put him on the lower strand of the ropes with a flurry of blows. Lane did not even bother to count and stopped the fight immediately, 50 seconds into the round.

"Once I saw he was hurt, I just threw caution to the wind," Tyson said. "I said, 'Just throw punches, just throw punches.

It was like Henry Armstrong, just keep throwing those punches.

"He was trying to hold me and I just wanted to keep punching, keep fighting. I knew he'd go down and he did," he continued. The 29-year-old Tyson raised his record to 44-1 with his 38th knockout.

Bruno was making his first title defense since winning the crown

with a 12-round decision over McCall last September. He fell to 40-

"I tried to use my weight against him, but he's a fast guy," he explained. "The cut worried me after

the first round. I tried to hold on and smother him, but he was just too quick. He done good, real good."

Tyson and Bruno were meeting for the second time. Tyson stopped Bruno in five rounds in 1989 in a title defense, but Bruno won the WBC version of the title in September by outpointing Oliver McCall.

"He fought better than last time," Bruno said of Tyson. "I'm just sorry I disappointed all the British fans who came here to see me and all the people in America who were pulling for me.

As for his possible retirement, Bruno said, "I'm going to take about 48 hours, sit down with my wife and family and decide about my future. I don't want to make any commitments right now."

At the weigh-in Thursday night, Tyson checked in at 220 pounds and Bruno at 247, nearly 20 pounds heavier than for their first fight.

The master plan for Tyson was to beat Bruno, then take Bruce Seldon's World Boxing Association title this summer and ultimately unify the title he once held by capturing the International Boxing Federation championship.




