# **Open Letter To Oregon Office Holders And Candidates**

#### Fellow Citizens:

We the members of Multnomah Monthly Meeting of the Religious Society of Friends write out of religious concern for the well being of Oregon's young people as they face difficult and changing times. Their moral health, their confidence in their ability to lead decent and productive lives, depends upon the education provided them by a society faced with the challenges and opportunities of profound economic change. We do not need to labor the point that equipping the young for the new job market as well as the complex demands of modern society will benefit all citizens, there being no more promising and constructive means of building strong and happy communities.

Public education in Oregon is under funded, and quality is threatened at all levels, from kindergarten to graduate school. It takes more than money to develop a strong system of education, but adequate funding is prerequisite to its development and necessary to its maintenance. Good models abound, in major American cities as well as in economically competitive nations such as Germany and Japan. In Oregon innovative approaches that have shown success and promise are now being damaged by program cutbacks and teacher layoffs. The trend must be reversed. Oregon needs thorough reform of

#### its tax structure. Measure 5, and with initiative.

Finally, open minded as we are as it dependence upon the real property to the details of change, we are very tax, must go. We realize there are many competing proposals, some representing various special interests. Among them we are aware of the following: Local option taxes for school programs, Governor Kitzhaber having recently suggested that school districts might be empowered to levy them after a study of essential educational costs and state funding of them; a gross receipts tax or sales tax that would exempt food, medicine, perhaps other basics; giving school districts a slightly larger share of tax revenues vis a vis cities and counties. Here we make no brief for any one or combination of these, recognizing that there are political realities to be faced as well as complex economic issues.

What we ask is an urgent effort requiring close cooperation of the Governor's office and the Legislature. We suggest that the process of reform might best begin through the joint leadership of the Governor, the Senate President, and the Speaker of the House. It might continue through the agency of a special commission charged with development of an equitable new tax structure to be acted upon in a special session of the Legislature. We urge such a course in order to forestall narrowly conceived efforts to alter the tax structure by

much concerned with principles. First, we believe that the quality of public education is a measure of a society's achievement and should be a source of joy and satisfaction for all. Secondly, we believe that funding should be equitable throughout the state, but, because the demands on school districts vary--for example the need for coping with many languages and difficult sociological conditions--truly equitable sharing of resources will not result from uniform per capita funding. Thirdly, we believe that taxation should be progressive,h)0\*0\*0\*e economically fortunate being expected to pay at a higher rate than those less so.

We trust that all of you care about this issue and that many feel the frustration of the present situation and the loss of public confidence in the legislative process. We sympathize with the difficulties of the wellintentioned as they feel the pressures of conflicting interests. Our hearts will be with you in your efforts to respond to the long range interests of the people of Oregon.

## **Lutheran Leader To Be Honored**

Gloria Edwards, president of a national Lutheran women's organization and principal of a Northern California construction company, will receive an honorary Doctor of Laws at Concordia University's May 18 commencement ceremonies, announced Concordia President Charles E. Schlimpert. One hundred and sixty bachelor's degrees will be awarded at the 10:00 a.m. event in the school's gymnasium.

Combined with 127 degree recipients at Winter commencement held in December, Concordia will be granting a record 287 degrees in the 1995-96 academic year.

Edwards, a resident of Portola Valley, is being recognized by Concordia University for her lifelong involvement in the Lutheran Church-Missouri Synod (LCMS), including serving as a member of the Concordia University Board of Regents since 1992.

Edwards has been involved in many community and church projects and organizations from the local PTA, her local congregation Bethany Lutheran Church in Menlo Park, the California-Nevada-Hawaii District of the LCMS Church as chair of the Committee on Women, to advisory broad membership to the Stanford University Young Women's Group.

She has served as a board member of the international Lutheran Women's Missionary League (ILWML) and in 1995 to emphasize mission education, mission inspiration, mission service and mission projects for women in the LCMS. The ILWML publication, Lutheran Women's Quarterly, provides inspirational articles, mission news, and Bible studies to the 2 million members of the LCMS.

Concordia University is one of 10 colleges and universities, including two seminaries, owned by the LCMS.

Edwards and her husband, Rosser, are founding principals of Webcor Construction of San Mateo, Calif. Webcor served as general contractor of Concordia's new science wing of Luther Hall.

"Bestowing this degree upon Gloria Edwards provides us with a wonderful opportunity to honor not only the service of a great leader, but women throughout the Lutheran Church-Missouri Synod," said Dr. Schlimpert. Edwards will give the commencement address.
