### Questions & Answers

Question: My daughter lives in Germany and I'm going to spend the summer with her. Will this affect my Social Security checks in any way?

Answer: When you are a United States citizen, you can travel or live in most foreign countries without affecting your eligibility for Social Security benefits. But you should call Social Security since you plan to go outside the U.S. for more than 30 days. We will send you special reporting instructions and tell you how to arrange for your checks. If you receive Medicare benefits, you should know that Medicare generally does not pay for hospital or medical services outside the United States. Social Security's toll-free number is 1-800-722-1213.

Question: If you retire early (age 62), what do you do about health benefits since you have to be 65 for Medicare benefits?

Answer: When you retire at age 62, you may be able to continue to have medical insurance coverage through your employer or, if not, you should purchase coverage from a private insurance company until you turn 65 and become eligible for Medi-

Question: If I hire a maid, do I have to deduct Social Security taxes from his/her pay?

Answer: If you hire a maid or other household worker directly, and pay \$1,000 or more in cash wages during the year, then you will have to deduct Social Security taxes and report the wages. However, if you go through an agency, and you pay that

household worker, then that agency deducts Social Security taxes from his or her wages along with other deductions that are appropriate. For more information, contact Social Security and ask for the fact sheet, Household Workers.

Question: I would like to know how much I have paid in Social Security taxes. I am also curious about how much I can expect to receive in Social Security benefits when I retire. Is there a way I can find out?

Answer: Yes. Call Social Security's toll free number, 1-800-722-1213, and ask for a Personal Earnings and Benefit Estimate Statement request form. After you fill it out and return it to Social Security, you should receive your personal statement in about four to six weeks. You may also request it from the Internet, at http://www.ssa.gov

Question: I'm going to hire a teenager in my neighborhood to watch my six-year-old this summer while I work. Do I need to report this to Social Security?

Answer: No. Earnings for household workers (such as baby sitters) under age 18 are exempt from the Social Security tax unless household employment is the worker's primary occupation.

Question: I need to call Social Security because I lost my Social Security card but I'm unable to get to a phone during the week during normal business hours. Can I get in touch with Social Security in the evening?

Answer: Yes, you can call Social Security's 24-hour toll-free number service. The number is 1-800-772-1213. Just listen to the pre-recorded message and select the number that directs you to get a replacement So-
