- Relocation of guard shelters at two gate sites. Furnishing and installation of a new guard shelter at one gate.
- Grading and paving at gate sites.
- Pulverizing and repaving approximately 1,400 square yards of perimeter road pavement.
- Construction of approximately 570 square yards of pave road at the east end of the perimeter road.
