## Notice Of Opportunity For Public Hearing

Notice is hereby given that a public hearing, if so requested by any interested person, will be held by the Tri-County Metropolitan Transportation District of Oregon (Tri-Met) at

3:30 pm, Wednesday, September 25, 1996 at the Portland Building, 1120 SW 5th Avenue, 2nd Floor, Room C., Portland, Oregon, for the purpose of considering a project for which federal assistance under the Intermodal Surface Transportation Efficiency Act of 1991 as amended (ISTEA), and Section 5309 of Title 49, U.S.C. is being sought. Persons requesting that this hearing be convened should contact Tri-Met's Grants Administrator, by telephone at (503) 238-4920, or in writing at 4012 SE 17th Ave., Portland, Oregon, 97202 by Thursday, September 12, 1996.

The project under consideration is Westside-Hillsboro Light Rail. Tri-Met received federal approval in September 1992 to design and construct the Westside rail project from downtown Portland to SW 185th Avenue in Washington County. In December 1994, the Federal Transit Administration approved and amendment to extend the rail line from SW 185th into downtown Hillsboro by Fall, 1998.

Fiscal year 1997 funding requested in this grant application for continuation of the rail project is up to \$115,000,000 in federal assistance under Section 5309 of Title 49, U.S.C. (Exact amount depends on Congressional action.) These federal funds would be matched with up to \$38,333,333 in local dollars.

Project expenditures will support civil construction including tunnel excavation; final design; procurement of vehicles, track, electrification, signals, communication and fare collection equipment, and other system requirements; right of way acquisition; and project administration.

A discussion of displacement of persons, families and businesses associated with the Westside-Hillsboro Project is included in Final Environmental Impact Statements on file at Tri-Met offices. The project is in conformance with comprehensive land use and transportation planning in the area and is programmed in regional and state Transportation Improvement Programs.

In the event a hearing is held, Tri-Met will afford opportunity for interested persons or agencies to be heard with respect to the social, economic, and environmental aspects of the project.

No bid for a construction contract will be received or considered unless the Bidder is registered with the Construction Contractors Board as required by ORS 671.530.

The successful Bidder will be required to provide Worker's Compensation coverage for employees. Bidders are required to certify non-discrimination in employment practices and identify resident status as defined in ORS 279.029.

Oregon Community Block Grant (OCDBG) funds are partially financing this project. Accordingly, Davis-Bacon wage rates apply to the project.

All Bidders are required to comply with the provisions of Oregon Revised Statutes. Attention is directed to ORS 244, Government Ethics; ORS 279, Public Contracts and Purchasing; Oregon Administrative Rules, Chapter 125, Division 300 to 360, Public Contract Exemptions; and Oregon Department of Justice Attorney General's Model Public Contract Rules Manual.

Contractors and subcontractors must be licensed under ORS 468A.720 and/or licensed by the Department of Environmental Quality ORS 279.025 (2) (i), as amended by 1987 Oregon Laws, chapter 741, section 18, if asbestos abatement is to be performed.

The Contractor will be required to certify on a form provided that, to the best of his or her knowledge and belief, no federal funds have been used for lobbying as described in Item 13 of the OCDBG Construction Contract Clause Supplement.

Each Bid shall be submitted on the prescribed form. Each Bid shall be accompanied by a surety bond, cashier's check, or certified check executed in favor of the City of Sweet Home in an amount equal to five percent (5%) of the amount of the Bid. The successful Bidder will be required to furnish a Performance and Labor and Materials Payment Bond in the full amount of the contract price. Should a Bidder fail to enter into a Contract and furnish the required Bonds within ten (10) working days after Contract forms are provided to the Bidder, the amount of the Bid Security will be forfeited to the owner as liquidated damages, but not as a penalty. Certificates of Insurance as required by the Supplementary General Conditions will be required.

The City of Sweet Home reserves the right to (1) reject any or all Bids not in compliance with all public bidding procedures, (2) postpone award of the Contract for a period not to exceed sixty (60) days from the date of bid opening, (3) waive informalities in the Bids, and (4) select the Bid which appears to be in the best interest of the City.
